ORDER

The University of Kerala vide paper read as (1) above, issued notification inviting applications for affiliation of new colleges/ courses/increase in intake/additional batches in affiliated colleges during 2022-23.

The Syndicate vide paper read as (2) above, considered the applications and resolved to conduct Local enquiry as envisaged in Statute 8, Chapter 24 of KUFS, 1977, in the colleges concerned and approved the inspection teams submitted by the Convenor, Standing Committee of the Syndicate on Affiliation of Colleges for conduct of local enquiry.

The Syndicate vide paper read as (3), considered the inspection reports submitted by the local enquiry teams and resolved to approve the recommendations of the meeting of the Standing Committee of the Syndicate on Affiliation of Colleges held on 29.04.2022. Accordingly, vide letter cited (4) above, views of the Government on starting new programmes recommended by the Syndicate was sought.

The Government vide order read (5) accorded administrative sanction to start new self-financing courses in Self-financing colleges affiliated to University of Kerala during the academic year 2022-'23. The Standing Committee of the Syndicate on Affiliation of Colleges vide paper read as (6) above considered the Government order and recommended to conduct another inspection at colleges by a team comprising of the Subject Experts concerned and Members of Syndicate. The recommendation was approved by the Syndicate vide reference (7) above.

The Standing Committee of the Syndicate on Affiliation of Colleges vide paper read as (8) considered the reports of the final inspection conducted in the colleges for affiliation of new courses and the committee recommended to grant conditional affiliation, as per Statute 12 Chapter 24 of the Kerala University First Statutes 1977, to the following new courses in the existing affiliated colleges, on self financing basis during the academic year 2022-'23 subject to fulfillment of procedural formalities of affiliation.

Further, the Standing Committee of the Syndicate on Affiliation of Colleges recommended to conduct a re-inspection at the above-mentioned colleges after six months to verify the facilities made available for the newly sanctioned programmes.

Also recommended to seek the views of the Government in starting BCA programme in Christ College, Vizhinjam during the academic year 2022-'23, in the light of request submitted by the Manager, Christ College, Vizhinjam vide letters cited (9) above.

The recommendations were approved by the Syndicate vide paper read as (10) above. Accordingly, vide letter cited (11) views of the Government was sought on starting BCA programme in Christ College, Vizhinjam.

The Government vide order read (12) accorded administrative sanction for starting new BCA course in Christ College, Vizhinjam during the academic year 2022-23 and the Vice Chancellor constituted inspection committee for conducting inspection in Christ Nagar College, Vizhinjam so as to ascertain the lab and library facilities made available in the college for commencement of new programme.

The Syndicate vide paper read as (13) considered the reports of the final inspection conducted in Christ College, Vizhinjam recommending to start the BCA programme with an intake of 40 seats by considering the available infrastructures and other arrangements for starting the programme and approved the same.

The Educational Agencies of all the above colleges mentioned have fulfilled the procedural formalities as prescribed by the University.

Sanction is therefore, accorded by the Vice Chancellor, for the Conditional Affiliation, as per Statute 12 in Chapter 24 of the Kerala University First Statutes, 1977, to the above mentioned new courses in existing Affiliated Colleges during the academic year 2022-'23.

The Affiliation granted is provisional and subject to the following conditions:

1. The admissions shall be made in accordance with the statutory regulations of the University and the State Government from time to time.
2. The management of the Institution shall not close the Institution or the Institution shall not discontinue instruction in any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the University.
3. No excess admission shall be made by the Institution over and above the approved intake under any circumstances.
4. The Institution shall not conduct any course(s) in the same premises / campus and / or in the name of the Institution without prior permission / approval of University.
5. No capitation fee shall be charged from the students / guardians of students in any form.
6. There shall not be any additional financial commitment on the part of the Government and the University.
7. The Un-aided Colleges shall have to pay the fee for Infrastructure Development and

Maintenance of the University before 31st March every year, in advance, as prescribed in the Ordinance, to provide service to these Course(s) as they are affiliated on condition that there will not be any additional financial commitment on the part of the Government / University.

8. All infrastructural and instructional facilities for higher semesters shall be made available in time to ensure the quality of education provided.
9. Further, the Institution shall strictly follow all the provisions contained in the Kerala University Act, 1974, the statutes framed there under, and the regulations prescribed by the Central Regulatory Bodies viz., UGC, NCTE, AICTE, BCI etc. Any violation of the above shall call for liability upon the Educational Agency.
10. The Educational Agencies shall execute agreement with the Government agreeing all the conditions prescribed in the government order granting administrative sanction to new course and produce NOC from the Government at the earliest.
11. The faculties appointed shall have NET qualification.
12. The colleges shall seek NAAC accreditation by 2023.
13. An undertaking agreeing to comply with all the above mentioned conditions and directions of the Syndicate of the University from time to time shall be submitted to the University forthwith.
14. The period of affiliation shall be one year/ till further orders by the University.
15. Continuance of affiliation to the new courses shall be granted only after conduct of Re-inspection to verify compliance to the requirements noted by the University.


