## GENERAL CONDITIONS

Sealed tenders are invited for the supply of the materials as specified in schedule attached below.

1. This **Bid is a single cover bid**. Technical bid and financial bid shall be submitted in the same cover, failing which bidder shall be disqualified.
2. The tenders should be addressed to the **Hon. Director, Centre for Renewable Energy and materials, (Room No 45; CLIF Buildings) University of Kerala Kariavattom Campus, 695581** in a sealed cover with the tender number and name – **Tender for the supply of “Solar panels and related accessories (Quantity: 1 No.)”** duly super scribed on the cover on or before **20/03/2024, 12.00 PM**
3. Tenders which are not in the prescribed form are liable to be rejected and the cost of tenderforms once paid will not be refunded.
4. Intending tenderers should send their tenders so as to reach the officer mentioned in the tender notification, on or before the due date and time noted therein. No tender received after the specified date and time will be accepted on any account. The rates will be considered firm for acceptance till the date mentioned therein. Tenders not stipulating period of firmness and tenders with price variation clause and/or ‘subject to prior sale’ condition are liable to be rejected.
  1. a. Every tenderer who has not registered his name with the State Government (Stores Purchase Department), should send along with his tender, an earnest money of Rs.3000/-. The amount may be paid in the form of **Demand Draft drawn in favor of the Finance Officer, University of Kerala, Thiruvananthapuram. Cheques will not be accepted.** The earnest money of unsuccessful tenderers will be returned as soon as possible after the tenders are settled.
  - b. Tenderers whose names are registered with Government (Stores Purchase Department) are generally exempted from furnishing earnest money for such articles for which they have registered their names. If they tender for stores other than those for which they have registered their names, they will have to furnish earnest money as in the case of unregistered firms. Registered firms will have to quote invariably in every tender they submit, the registration number assigned to them by the Stores Purchase Department. Attested copy of registration certificate may be enclosed with the tender for reference.
  - c. Small Scale Industries and Cottage Industries within the Kerala state, which are certified as such by the Director of Industries and Commerce or by the Regional Joint Director of Industries and Commerce will be exempted from furnishing earnest money against tenders for supply of stores manufactured by them.
2. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money, if any deposited by him will be forfeited to University of Kerala or such action taken against him as the University think fit.
3. The final acceptance of the tender rests entirely with the University who do not bind themselves to accept the lowest or any tender. But the tenderers on their part should be prepared to carry out such portion of the supplies included in their tender as may be allotted to them.
5. In cases where a successful tenderer, after having made partial supplies, fails to fulfil the contracts in full, all or any of the materials not supplied may at the discretion of the Registrar, be purchased by means of another tender/quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to the University shall thereby, together with such sums as may be

fixed by the University towards damages, be recovered from the defaulting tenderer.

6. Payment will be made only after the supplies are actually verified and taken to stock.
7. The contractor shall not assign or make over the contract or the benefits or burdens thereof to any other person or body corporate. The contractor shall not underlet or sublet to any person or persons or body corporate the execution of the contract or any part thereof without the consent in writing of the Registrar who shall have absolute power to refuse such consent or to rescind such content (if given) at any time if he is not satisfied with the manner in which the contract is being executed and no allowance or compensation shall be made to the contractor or the sub-contractor upon such recession. Provided always that if such consent be given at any time, the contractor shall not be relieved from any obligation, duty or responsibility under this contract.
8. The tenderer shall undertake to supply materials according to the standard sample and/ or specifications
9. No representations for enhancement of rates once accepted will be considered.
10. Any attempt on the part of the tenderers or their agents to influence the University in their favor by personal canvassing with the officers concerned will disqualify the tenderers.
11. Samples would be forwarded if called for an unapproved samples got back by the tenderers at their own cost. Samples sent by V.P. Post for 'freight to pay' will not be accepted. The approved samples may or may not be returned at the discretion of the undersigned. Tenderers whose samples are received late will not be considered. Tenders for the supply of materials are liable to be rejected unless samples if called for, of the materials tendered for are forwarded.
12. **EMD and Tender Fee:** - The bidder shall furnish EMD and Tender fee as mentioned in Tender Notice. Exemption Certificate if any, shall be submitted along with the tender.
13. **Deliver:** - The item should be delivered at the office of the **Centre for Renewable Energy and Materials- Kerala University Kariavattom Campus.**
14. **Installation and Commissioning:** - The items shall be installed and commissioned at the office of the Centre for Renewable Energy and Materials- Kerala University Kariavattom Campus.
15. **Warranty/Guarantee :-**
  - i) The supplier shall guarantee to repair/ replace the items or its part if found defective within **the warranty (Defect Liability) period of 2 year** of the items, the warranty of which are not mentioned Estimate. For other items supplier shall replace the item within the warranty period mentioned in Specification/estimate.
  - ii) The entire expenditure for repair/ replaces the item in this regard shall be borne by the supplier. Warranty shall be applicable for entire item.
