## ORDER

The University Grants Commission (Minimum Qualifications for appointment of Teachers and other Academic Staffs in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations 2010, was gazetted on the recommendation of the Academic Council of the University of Kerala dated 23.11.2013 vide paper read as (1) above.

The Hon'ble High Court of Kerala vide Judgment read as (2) above, had ordered that all appointments made with effect from 18-09-2010 had to be in tune with UGC Regulations, 2010 irrespective of whether the University Acts or the Statutes are amended in line with UGC Regulations or not, in view of its adoption by the State of Kerala w.e.f 18-09-2010 as per G.O(P) No: 392/2010/H.Edn, dated 10-12-2010.

Consequently, the Government as well as the University proceeded to file a Special Leave Petition before the Hon'ble Supreme Court of India, for extending the date of applicability of the UGC Regulations, 2010, which was disposed by the Apex Court vide paper read as (7) above.

However, the University vide papers read as (3), (4), (5) and (6) above has approved the templates for Career Advancement Scheme for teachers based on Academic Performance Indicators (API) and Performance Based Appraisal System (PBAS) in the University Departments and Aided Colleges, and norms and procedures for the appointment of Principals in Aided Colleges, as stipulated in the UGC Regulations 2010.

As per the directions of the Apex Court, in the SLP mentioned above in para(3), the UGC Regulations,2010 were to be implemented on a date not later than 23.02.2016, i.e., the date of Judgement of the Hon'ble High Court of Kerala, or on an earlier date, provided the Universities concerned had done so.

The session of the Syndicate, vide paper read as (8) above, resolved to place the whole matter before the Academic Council. The Academic Council vide paper read as (9) above, considered the matter and resolved as follows.

- 1. The Academic Council noted the Jugdement of the Hon'ble Supreme Court of India on SLP filed with regard to the effective date of implementation of the UGC Regulations 2010 and resolved that the said regulations shall be treated as implemented in the University with effect from 23.02.2016, amending the earlier notification in this regard.
- 2. Further resolved that, other than for appointment through Direct Recruitment, the conditions stipulated in Kerala University Act 1974, Chapter VIII Clause 57(2) (3) relating to appointment of Principals by promotions in Private Aided Colleges, through the criteria of Seniority-cum-fitness shall be valid subject to the fullfilment of academic qualifications prescribed by the UGC.

3. Also resolved that the extension of effective dates of participation in Refresher/Orientation courses under 1998 regulations shall be made applicable to all those teachers whose date of promotion falls on or before 31.12.2013.

4. Also resolved to approve the simplified templates for API scores along with the modifications in proforma for CAS promotions of teachers in Colleges and University Departments, with the teachers being allowed to exercise option of UGC Regulations 1998 or 2010 for the purpose of Placement/Promotion due upto 23.02.2016.

Sanction has therefore been accorded by the Vice Chancellor to implement the resolution of the Academic Council and to revoke the related provisions of the U.O read as (3), (4), (5) and (6) above, after obtaining legal vetting.

The U.O read as (3), (4), (5) and (6) above stands modified to the above extend.

The modified Performance Based Appraisal System (PBAS) and API templates for Placement /Promotion of teachers under Career Advancement Scheme shall be down loaded from the University website.

Orders are issued accordingly.
