Qualifications:

I).Good Academic record with at least 55% marks or an equivalent grade at Master Level in relevant subject from an Indian University or an equivalent Degree from a Foreign University in the following subjects.

Note:1 Candidates besides fulfilling the above qualification should have cleared the eligibility test for Lectureship conducted by UGC/CSIR or similar test accredited by the UGC.

However candidates who have hold Ph.D Degree in the subject concerned are exempted from NET qualification.

Note.2 Relaxation of 5% marks at Masters Level is allowed to Ph.D degree holders who have passed their Masters Degree prior to 19.10.1991.

II). First Class Masters Degree in Technology Management (ME/M.Tech). In the absence of the candidates with above qualifications, First Class Masters Degree holders (ME/M.Tech) in Electronics and Communication/ Computer Science and Engineering /IT will be considered. The candidates must have undergone an AICTE approved programme for the above qualifying degree. Such candidates is also exempted from passing UGC,NET.

Note.3 Candidates belonging to Scheduled Caste/Scheduled Tribe/Differently-abled (Physically and visually differently-abled)/Other Backward Classes (OBC) (Non Creamy Layer) categories are eligible for relaxation of 5% marks for the purpose of eligibility at the Graduate and Masters level for attending the interview . **The eligibility marks of all candidates (with or without relaxation) will be based only on the qualifying marks without including any grace mark procedures.**

AGE: Not more than 40 years as on 01.01.2016. Normal relaxation as per Govt/University rules to reservation category.

3. Eligibility Certificate / Equivalency Certificate issued by the University of Kerala stating that your qualifying degrees issued by other Universities, if any, are equivalent to that of the University of Kerala.
4. Experience Certificate(s).
5. Valid Caste Certificate/Non-Creamy Layer Certificate (If you claim reservation).
6. ID proof(Voters ID Card/Aadhaar Card/Driving Licence etc)
7. Certificate to prove age.
8. Other relevant documents in support of your application as per notification.

If the candidate does not possess the prescribed qualification or in the event of failure to produce the necessary documents in original at the time of interview, he/she will not be permitted to attend the interview.
