Election of a representative of the University of Kerala to the General Council of the Kerala Agricultural University from among the members of the Senate

(Under Section 10- Other members (1) of the Kerala Agricultural University Act, 1971)

NOTIFICATION

It is hereby notified that an election will be held to elect a representative of the University of Kerala to the General Council of the Kerala Agricultural University from among the members of the Senate, as required under Section 10 - Other Members (1) of the Kerala Agricultural University Act, 1971.

Only those persons whose names are included in the electoral roll published by the University on **24.08.2026** shall be eligible to participate in the election and to vote therein, subject to the provisions of the Kerala University Election Statutes.

Copies of the Electoral roll are available for sale in the University Office on payment of Rs.100/- per copy and also can be downloaded from the Kerala University website.

Every elector is at liberty to nominate one duly qualified person to fill up the vacancy. Every such nomination shall be proposed by an elector and shall be seconded in writing by another elector. Every such nomination shall contain an affidavit and the consent of the nominee agreeing to serve the concerned body, if elected. Nominations shall be made in the prescribed form, copies of which can be had from the office of the Registrar as well as from the University website.

Nominations duly filled in, in all respects should reach the Registrar/Returning Officer not later than **11.30 a.m. on 16.09.2026**. Nominations if sent by post should be enclosed in an envelope superscribed **“Nomination for election to the General Council of the Kerala Agricultural University”**.

The polling for the above election shall be held from **8.30 a.m. to 10.00 a.m. on 28.09.2026 at the meeting of the Senate, in the Senate Chamber, University Buildings, Thiruvananthapuram.**
