ORDER

The clause '6' of the University Order vide paper read as (1) above states that "The students shall attend afresh the University examinations of the paper(s) in which he/she has improved the internal assessment as special appearance. The earlier marks secured by the candidates (Internal and University examinations) in the concerned paper(s) will stand cancelled on registration to the University examinations after completion of the internal improvement". Several students aggrieved by this clause had submitted representations for the modification of the same.

The Academic Council vide paper read as (4) above, considered the proposals along with the Judgements of the Hon'ble High Court of Kerala vide paper as (3) above, put forwarded by the Examination Wing for modifying the existing guidelines for improvement of internal assessment as special appearance to LL.B candidates and resolved to approve the following recommendations for modifying the existing regulations.

- 1. The notification for the Internal Improvement which is normally issued in the month of December be notified sufficiently earlier for the respective year ie immediately after one year of the completion of the course.
- 2. In cases where the results of the supplementary examinations have not been published, but were held prior to the sanction order, the improved CA marks be added to the ESA marks of the Supplementary Examinations held at the prior date.
- 3. Currently the mercy chance candidates were permitted to add the internal re-appearance marks to the previous supplementary examinations. This benefit shall be extended to the candidates from 2011 Schemes also.
- 4. The following clause in University Order vide paper read as (2) above," mercv chance candidates for LL.B (3year/5year) degree courses be permitted to add the internal re-appearance marks to their previous supplementary ESA to obtain minimum pass marks only" be modified as "the internal re-appearance marks be added to the ESA of Regular/Supplementary/Mercy chance examinations to enable the candidates to pass the subject".

The University Orders vide papers read as (1) & (2) above stands modified to this extent.

Orders are issued accordingly.
