### **NOTIFICATION**

Applications are invited from qualified candidates for appointment to the posts of Lecturer in the following Teaching Departments of the University.

Appointments to the posts will be made in accordance with Section (6) Sub Section (2) of Chapter II of the Kerala University Act,1974.

The turn of appointment as per the principles of rotation is given against each post.

#### **Qualifications:**

Good Academic record with at least 55% marks or an equivalent grade at Masters Degree level in the relevant subject from an Indian University or an equivalent Degree from a Foreign University.

**Note: 1** Candidates besides fulfilling the above qualifications should have cleared the eligibility test for Lectureship conducted by the UGC, CSIR or similar tests accredited by the UGC.

However, the candidates who are, or have been awarded a Ph.D Degree in accordance with the UGC (Minimum Standards and Procedures for Award of Ph.D Degree) Regulations, 2009, shall be exempted from the requirement of NET qualifications.

**Note: 2** A relaxation of 5% marks at Masters level is allowed to the following categories

1. SC/ST Candidates
2. Ph.D Degree holders who have passed their Masters Degree prior to 19.09.1991

#### **Age**

Not more than 40 years as on 01.01.2013

Usual relaxation in the upper age limit shall be allowed in respect of candidates belonging to SC/ST and Other Backward Classes. Relaxation in the upper age limit will also be allowed in the case of persons already in the teaching service of the University and qualified teachers of affiliated colleges and UGC qualified technical staff (non-teaching) of the University Service who are above the age of 40.

Cost of Application form Rs.150/- (Rs.160/- if remitted as DD) and Registration Fee Rs.250/- (Rs.260/- if remitted as DD). In the case of SC/ST candidates the Registration Fee is Rs.62.50/- (Rs.72.50/- if remitted as DD)

1. The prescribed application form and other details can be downloaded from the website of the University ([www.keralauniversity.ac.in](http://www.keralauniversity.ac.in)). Only downloaded applications will be accepted. Such applications will be entertained only if the candidates have remitted the cost of application form along with the Registration fee.

**Mode of remittance:**

a) Cost of application form and Registration fee be remitted by DD drawn on State Bank of Travancore / District Co-operative Bank, in favour of **"The Finance Officer, University of Kerala"** payable at State Bank of Travancore Service Branch, Thiruvananthapuram and State Co-operative Bank, Head Office Branch, Thiruvananthapuram respectively.

b) Postal Orders, Money Orders, Cheques and DDs from other Banks and DD drawn on Kariavattom Branch will not be accepted.

c) Candidates residing outside the state may however send DDs drawn on State Bank of India in favour of **"The Finance Officer, University of Kerala"** payable at State Bank of India, Main Branch, Thiruvananthapuram.

d) Remittance towards the cost of application forms and Registration fee will also be accepted in cash by chalan at the Kerala University Cash Counter, University Buildings, Thiruvananthapuram and also at the Friends Counters (Jana Sevana Kendram) at Thiruvananthapuram.

Completed application along with DD/Chalan for prescribed cost of application form and registration fee, copies of certificates, testimonials, etc. duly attested by a Gazetted Officer, should reach the Deputy Registrar (Admn.III) University of Kerala, Thiruvananthapuram – 695 034 on or before **30.08.2013**.

**Candidates who are employed should forward their application through proper channel or enclose NOC of employer.**

Candidates who have passed their qualifying examinations from Universities other than University of Kerala should furnish an **Eligibility Certificate issued by the University of Kerala**, stating that their qualifying degrees issued by other Universities, are equivalent to that of the University of Kerala, along with their application.

OBC candidates have to produce certificate issued by competent authorities, certifying that they **do not belong to the Creamy Layer**.

Candidates, if shortlisted for the interview, should appear for the same at Thiruvananthapuram at their own expense.

**N.B:**

**1) Incomplete and defective applications will be summarily rejected. No interim enquiries will be entertained.**

2) Submission of application does not entitle the applicant any right to be appointed or be called for interview. The University reserves the right to accept/reject the applications or to re-notify the post without assigning any reason.
