The meeting was called to order at 10.00 a.m. by Prof.(Dr.) P.K.Radhakrishnan, Vice-Chancellor in the Chair. He welcomed the members to the meeting.

Thereafter, the Vice-Chancellor informed the Council of the demise of Dr. K.B.Rajeev, Principal, Government Sanskrit College, Thiruvananthapuram, Member of the Academic Council.

The Council observed a minutes' silence in reverence to the departed soul.

(I) Business brought forward by the Vice-Chancellor and the Syndicate.

01. Recognition of M.Sc. Degree in Computer Science through Distance Education – awarded by Bharathiar University – Request received from Sri. Shaji. N. Raj – Consideration of – reg. (Ac.C)

Sri. Shaji. N. Raj applied for course recognition of M.Sc. Degree in Computer Science awarded by Bharathiar University, Coimbatore through distance mode as equivalent to M.Sc. Computer Science of the University of Kerala for employment in Government Sector./

The annual meeting of the Board of Studies in Computer Science (PG) recommended to recognize the M.Sc. Computer Science (Distance) awarded by Bharathiar University as equivalent to M.Sc. Computer Science Degree offered through School of Distance Education of this University and the Faculty of Applied Sciences held on 11.03.2015 endorsed the same.

The Academic Council at its meeting held on 19.05.2015 considered the same and referred the item back to the Board of Studies in Computer Science (PG). The matter was therefore placed before the Board of Studies in Computer Science (PG) and the Board remarked that the issue was referred back to the Board of Studies by the Academic Council due to the argument that giving recognition to any degree (through distance mode) of any other University as equivalent to a corresponding Degree (through Distance Mode) of Kerala University is not valid since Kerala University does not give any degree as distance mode degree by explicitly mentioning it in the Degree Certificate. The Board of Studies also opined that M.Sc.Computer Science Degree (through distance mode) of even Kerala University cannot be equated to the corresponding degree of Kerala University through Regular mode as the mode of Education, Admission eligibility criteria, Scheme & Syllabus etc. are different and considerable amount of practical classes imparted through distance mode cannot be compared to that imparted through Colleges (Regular mode).

The Board of Studies therefore suggested that the issue may be placed before the Academic Council as an independent item and clear guidelines may be given on the same, since several similar issues are coming before the Board of Studies. The Dean noted that he is unaware of such an argument as stated by the Board of Studies and suggested that the matter may be placed before the Academic Council for a final decision along with a Statement of facts regarding the Degree Certificate given. In the Degree Certificates awarded to students undergoing courses through distance mode in Kerala University, it is not explicitly shown as 'distance mode'.

The Standing Committee of the Academic Council recommended to recognize the M.Sc. Degree in Computer Science through Distance Education awarded by Bharathiar University as an eligible qualification for the purpose of higher studies and employment.

The Academic Council considered the above matter and **RESOLVED** to refer the matter to the Board of Studies in Computer Science (PG) for specific recommendation.

02. Recognition of B.A Degree (Tourism Studies) awarded by Indira Gandhi National Open University (IGNOU), New Delhi – Request received from Sri. Arun Sankar.R. – Consideration of - reg. (Ac.C)

Sri. Arun Sankar.R, applied for course-recognition of the B.A Degree (Tourism Studies) awarded by Indira Gandhi National Open University (IGNOU) ,New Delhi for the purpose of employment. It may be noted that the BTS (Bachelor of Arts) (Tourism Studies) of IGNOU has been recognized by this University for admission to LLB and MBA programme.

The additional meeting of the Board of Studies in Business Management (Pass), held on 02 /4/ 2016 considered the remarks of the Dean, Faculty of Management Studies that the Degree obtained by the candidate can be recognized for getting admission to MBA Degree programme of the University of Kerala and for employment purpose at par with other B.A. Programmes and recommended to take an appropriate decision.

The Standing Committee of the Academic Council recommended to recognize B.A.Degree(Tourism Studies) awarded by Indira Gandhi National Open University, New Delhi, as an eligible Degree for the purpose of employment and higher studies, for which recognized Degree in any subject is the minimum qualification prescribed.

The Academic Council considered the above matter and **RESOLVED to** recognize the B.A.Degree (Tourism Studies) awarded by Indira Gandhi National Open University, New Delhi, as an eligible Degree for the purpose of employment and higher studies, for which recognized Degree in any subject is the minimum qualification prescribed.

03. Recognition of M.Sc. Degree in Computer Science through Distance Education awarded by Annamalai University – request received from Smt. Raji Gopinathan. N.- Consideration of - reg. (Ac.C)

Smt. Raji Gopinathan.N., applied for course recognition of M.Sc. Degree in Computer Science through Distance Education awarded by the Annamalai University for the purpose of promotion and higher studies.

The Chairman, Board of Studies in Computer Science (P.G), remarked that the said course cannot be recognized and the Dean, Faculty of Applied Science and Technology opined that University of Kerala runs M.Sc. Degree in Computer Science through School of Distance Education and the equivalence of the applicant's P.G Programme through Correspondence to our M.Sc. Degree in Computer Science (Distance) is to be examined. Further remarked that in view of the multiple parameters to be taken into consideration (Institute of Distance Education Mode, Lateral Entry and lack of continuous assessment) the matter be placed before the Board of studies in Computer Science (P.G) for consideration.

The Annual Meeting of Board of Studies in Computer Science (P.G) held on 21/01/2016, vide item No.V, considered the matter and pointed out that the Academic Council at its meeting held on 19/05/2015 returned a similar course recognition file to the Board of Studies for reconsideration. It is stated that the argument in the Academic Council was that giving recognition to any degree through (Distance Mode) of other Universities as equivalent to a corresponding degree through distance mode of Kerala University is not valid since Kerala University does not give any degree as distance mode degree by explicitly mentioning the same in the degree certificate. The Board of Studies also opined that M.Sc. Degree in Computer Science (distance mode) of Kerala University cannot be equated to corresponding degree (regular mode) of Kerala University as the mode of Education, admission, Eligibility criteria, Scheme and

Syllabus etc. are different. Moreover it is stated that practical and project work of regular M.Sc. Degree in Computer Science and distance M.Sc. Degree in Computer Science differ. Hence it is suggested that this may be placed before the Academic Council as separate item for giving clear guidelines. The Dean, Faculty of Applied Science and Technology remarkedthat he is unaware of any such argument and disagree with the said argument that merely because the degree certificate does not explicitly state distance mode such mode cannot be equated. The Dean has suggested to place the matter before the Academic Council with a statement of facts regarding the degree certificates given. It is clarified that in this University distance mode is not explicitly mentioned in the degree certificate of M.Sc. Degree in Computer Science course offered through School of Distance Education or in any other degrees awarded to School of Distance Education candidates.

The Standing Committee of the Academic Council recommended to recognize M.Sc. Degree in Computer Science through Distance Education awarded by Annamalai University as eligible qualification for the purpose of higher studies and employment

The Academic Council considered the above matter and **RESOLVED** to refer the matter to the Board of Studies in Computer Science (PG) for specific recommendation.

04. Recognition of B.A.Degree in History (Distance) awarded by Vinayaka Missions University (Deemed) – Request received from Sri.Safir. P.K. - Consideration of – reg. (Ac.C)

Sri. Safir. P.K., applied for course recognition of the B.A.Degree in History (Distance) awarded by Vinayaka Missions University (Deemed) for the purpose of higher studies and employment.

The Chairman, Board of Studies in History (Pass), remarked that the B.A.Degree in History (Distance) awarded by Vinayaka Missions University (Deemed) can be recognized as equivalent to B.A.Degree in History of the University of Kerala. The Dean, Faculty of Social Sciences referred the same to the Academic Council for deliberations and decision.

The Standing Committee of the Academic Council recommended to recognize B.A.Degree in History (Distance) awarded by Vinayaka Missions University (Deemed) as equivalent to B.A.History of University of Kerala.

The Academic Council considered the above matter and **RESOLVED** not to recognize the B.A.Degree in History (Distance) awarded by Vinayaka Missions University (Deemed).

05. Recognition of M.B.A Programme (Regular) awarded by the Kerala University of Fisheries and Ocean Studies (KUFOS), Panangad, Kochi – Consideration of - reg. (Ac.C)

The Hon'ble Vice-Chancellor, Kerala University of Fisheries and Ocean Studies (KUFOS),Panangad,Kochi sought course recognition of the M.B.A Programme (Regular) awarded by Kerala University of Fisheries and Ocean Studies (KUFOS), Panangad, Kochi for the purpose of considering the matter of equating the same as equivalent to the M.B.A.Programme of the University of Kerala for higher studies and employment.

The Standing Committee of the Academic Council recommended to recognise M.Sc. Degree in Chemistry (Regular) awarded by Noorul Islam Centre for Higher Education, Kumaracoil, as equivalent to M.Sc. Chemistry of the University of Kerala.

The Academic Council considered the above matter and **RESOLVED** to entrust the Registrar to verify and report whether the M.Sc. Degree Course (Regular) in Chemistry conducted by Noorul Islam Centre for Higher Education, Kumaracoil (Deemed) has commenced and a batch has completed the Course. Further resolved that the matter be referred back to the Board of Studies for a detailed study.

13. Afzal-ul-Ulama Preliminary with Part II English exemption - already passed Part I English of HSE – Consideration of - reg. (Ac.A.II)

Sri. Anas.A., and Smt.Surumi Shajahan candidates who have passed Part I English of the Higher secondary Examination Government of Kerala and subsequently passed Afzal-ul-Ulama Preliminary examination from University of Calicut applied for Private registration for B.A Arabic in 2014. English forms Part II of the Afzal-ul-Ulama exam and in the marklist of the Afzal-ul-Ulama (Preliminary) issued to the candidates it is noted as 'exempted' against Part II English, which imply that such an exemption is extended by the University of Calicut. In the Government Order (RT)No.2165/2014/Higher Education Department. dated 03/06/2014, it is stated that Afzal-ul-Ulama Preliminary course is equivalent to +2 course (Humanities group),.

The Private registration section sought clarification regarding whether the candidates who have passed Part I English of Higher secondary Examination and exempted from appearing Part II English of the Afzal-ul-Ulama preliminary examination by the University of Calicut can be accepted as eligible and be granted registration for B.A Arabic Degree course.

The Chairman Board of studies in Arabic (Pass) remarked that, as the Calicut University has given exemption for appearing for the Part II English of Afzal-ul-Ulama Preliminary examination and the candidates have also been given pass certificate of Afzal-ul-Ulama (Preliminary) they can be considered eligible for registration to B.A Arabic course of this University accepting the exemption granted by the competent authority. The Dean, Faculty of Oriental Studies endorsed the remarks of the Chairman.

The Standing Committee of the Academic Council recommended to recognise Afzal-ul-Ulama (Preliminary) qualification of Calicut University granted reckoning Part-I English of HSE in lieu of Part-II English of Afzal-ul-Ulama (Preliminary), as an eligible qualification for higher studies.

The Academic Council considered the above matter and **RESOLVED** not to recognise Afzal-ul-Ulama (Preliminary) qualification granted by Calicut University reckoning Part-I English of HSE in lieu of Part-II English of Afzal-ul-Ulama (Preliminary).

14. MBL three year (6-Semester) Degree Course (2009 scheme) - Clarification of Clause 14(2) of the Regulations – Recommendation of the Deans' Council – Consideration of - reg. (Ac.A.III)

As per the Regulations of MBL Degree Course (2009 scheme), Clause 14(2)-"Admission to MBL (2-year) semester Degree holders :- MBL (2-year) semester Degree holders of this University may be admitted to the MBL (3-year) semester Degree Course and after successful completion of the 1st and 2nd semesters, a certificate to that effect may be issued."

The Board of Studies in Law (PG) at its additional meeting held on 23/10/2014 considered the clarification sought regarding issuance of Certificate noted in Clause 14(2) and recommended the following which was endorsed by the Faculty of Law at its additional meeting held on 12/11/2014. "Those who have successfully completed two year MBL (semester) Degree Course and successfully completed I and II semesters of three year MBL may be asked to surrender their MBL certificates and new certificates be issued thereby incorporating S1 and S2 of three year MBL and four semesters of two year MBL Programme."

As the recommendation was not feasible, the Academic Council held on 19th May 2015 vide item no. 52, referred back the matter to the Faculty of Law for recommendation and the Faculty of Law at its additional meeting held on 08.10.2015 referred back to the Board of Studies in Law (PG) for remarks, and approved by the Academic Council held on 19.10.2015.

The Board of Studies in Law (PG) at its annual meeting held on 18.12.2015, considered the matter and recommended that a separate certificate may be issued to the candidates who had successfully completed the 1st and 2nd semesters of the MBL (3-year) semester Degree Course incorporating the details of the subjects covered under the 1st and 2nd semesters of the MBL (3-year) semester Degree Course as specified in the Regulations; to the effect that the candidates had completed three year MBL Degree Course. The Faculty of Law at its annual meeting held on 10.02.2016 endorsed the same whereas the Academic Council at its meeting held on 18.04.2016 referred the matter to the Deans' Council for detailed study and specific recommendation.

The Deans' Council held on 20.05.2016 vide item no. 9 considered the matter and recommended the following: "A Separate Certificate be issued to such candidates who had successfully completed the I and II semesters of the MBL (3 year) semester Degree course incorporating the details of the subjects covered under the I and II semesters of the MBL (3 year) Degree Course as specified in the Regulations; to the effect that the candidates had completed three year MBL Degree course." It was also emphasised by the Council that the question of granting equivalence to MBL Degree with LLM does not arise now.

The Standing Committee of the Academic Council recommended to approve that 'Certificates be issued to the candidates in question who had successfully completed First and Second Semesters of the MBL (3 year) Semester Degree Programme, incorporating the details of subjects/ courses covered under Part I and II of the MBL (3 Year) Programme as specified in the Regulations, to the effect that such candidates have completed three year MBL Degree Programme. It is also reiterated by the Council that the question of granting equivalence to MBL with that of LL.M Degree Programme doesn't arise'.

The Academic Council considered the above matter and **RESOLVED** that 'Certificates be issued to *MBL (2-year) semester Degree holders* who had successfully completed First and Second Semesters of the MBL (3 year) Semester Degree Programme, incorporating the details of subjects/ courses covered under I and II Semesters of the MBL (3 Year) Programme as specified in the Regulations; to the effect that such candidates have completed three year MBL Degree Programme.

Further resolved that the question of granting equivalence to MBL with LL.M Degree Programme does not arise.

15.Recognition of M.E.Degree in Computer Science & Engineering (Part-time)
awarded by Anna University – Consideration of – reg.(Ac.A.III)

The Academic Council at its meeting held on 18-04-2016 resolved to grant recognition to the M.E. Degree in Computer Science & Engineering (Part-time) awarded by Anna University, Chennai as equivalent to M.Tech. Degree in Computer Science & Engineering (Part-time) of the University of Kerala for higher studies and employment as recommended by the Board of Studies in Engineering (PG) at its meeting held on 19-08-2015 and endorsed by the Faculty of Engineering & Technology at its annual meeting held on 05.03.2016. It was later noted that the University of Kerala does not offer M.Tech. Degree Course in Computer Science & Engineering under Part-time mode.

The Chairman, Board of Studies in Engineering (PG) remarked that 'the Part-time and Full-time M.Tech. Degree Programmes of the University of Kerala follow the same subjects and syllabi for study. The no. of credits, evaluation/assessment criteria, minimum marks for pass, no. of hours/week for a subject etc. are same and the examination is common for both Full-time and Part-time Programmes. The only difference is in the duration of the Programme as the no. of instruction hours/week available for Part-time Programme is less and hence the curriculum of M.Tech. Programme is restructured to extend over a longer period'. Hence the Chairman recommended that the M.E. Degree in Computer Science & Engineering (PT) awarded by Anna University can be considered as an eligible qualification for higher studies and employment for which M.Tech. (Regular – Full-time) Degree in Computer Science & Engineering & Technology endorsed the recommendation of the Chairman, Board of Studies in Engineering (PG).

The Standing Committee of the Academic Council recommended to recognise M.E Degree in Computer Science & Engineering (Part time) awarded by Anna University as an eligible qualification for higher studies and employment in the field of Computer Science, for which M.Tech (Regular-Full time) is the prescribed qualification.

The Academic Council considered the above matter and **RESOLVED** not to recognise the M.E Degree in Computer Science & Engineering (Part time) awarded by Anna University.

16. Recognition of M.Sc. Degree in Botany (Regular) awarded by Bharathiar University, Coimbatore through Kongunadu Arts and Science College (Autonomous) – Request from Smt. Divya. K.R. - Consideration of – reg. (Ac.C) Smt. Divya. K.R., applied for course recognition of the M.Sc. Degree in Botany (Regular) awarded by Bharathiar University, Coimbatore through Kongunadu Arts and Science

College (Autonomous) for the purpose of employment (for Asst. Professor post approval). The Chairman, Board of Studies in Botany (PG) remarked that the M.Sc. Degree in Botany (Regular) awarded by Bharathiar University, Coimbatore through Kongunadu Arts and Science College (Autonomous) can be recognized as an equivalent qualification for the approval of appointment to the post of Assistant Professor in the subject Botany. The Dean, Faculty of Science endorsing the recommendation of the Chairman, remarked that the said course can be recognized as equivalent to M.Sc. Degree in Botany of the University of Kerala for the purpose of higher studies and employment in the field of Botany.

The Standing Committee of the Academic Council recommended to recognise M.Sc. Degree in Botany (Regular) awarded by Bharathiar University, Coimbatore through Kongunadu Arts and Science College (Autonomous) as equivalent to M.Sc. Degree in Botany of the University of Kerala.

The Academic Council considered the above matter and **RESOLVED** to recognise the M.Sc. Degree in Botany (Regular) awarded by Bharathiar University, Coimbatore through Kongunadu Arts and Science College (Autonomous) as equivalent to M.Sc. Degree in Botany of the University of Kerala.

17. Change of Nomenclature of the Dual Degree Programme in Management to Five Year Integrated MBA – Consideration of - reg. (Ac.A.IV)

The Academic Council held on 18.04.2016 resolved to approve the nomenclature of dual degree in Management commenced at MSN Institute of Management and Technology, Chavara during the academic year 2015-2016 as "Integrated BM – MAM course" based on the recommendation of the Chairman, Board of Studies in Business Management (PG) and Dean, Faculty of Management Studies and UO No. AcAIV/1/Integrated MB-MAM/2016 dated 06.05.2016 issued.

As the nomenclature BM/MAM is not in line with the specification of nomenclature notified by the UGC, extension of approval was granted by the AICTE for "Five Year Integrated MBA" instead of Dual Degree BM/MAM, citing the following;

- i. he Dual Degree Course (s) have been closed and no fresh admission should be permitted from the Academic Year 2016-2017
- ii. The Institutions who were running dual degree courses(s) are given Extension of Approval for Five (5) years Integrated MBA course in lieu of Five (5) years dual degree courses of BM / MAM introduced by AICTE.

The Chairman, Board of Studies in Business Management (PG) remarked that in the light of the decision of AICTE, the Dual degree BM-MAM programme may be renamed as "Five year Integrated MBA" course with an exit option at the end of the Third year (Sixth semester) to receive a bachelor degree viz Bachelor of Business Administration (BBA). The existing Scheme, Regulations and Syllabus of the BM-MAM degree programme remain same for the Five year Integrated MBA course without any modification. The Dean, Faculty of Management Studies endorsed the remarks of the Chairman, BoS in Business Management (PG) and remarked that the existing admission procedure, Scheme and syllabus of the Dual Degree BM-MAM programmes can be made applicable for the Five year Integrated MBA programme and the nomenclature of BM-MAM shall only be changed to "Five Year Integrated MBA" course.

The Standing Committee of the Academic Council recommended that the existing admission procedures, scheme and syllabus of the dual Degree BM-MAM Programme be made applicable for the 5 year Integrated MBA Programme and the nomenclature of BM-MAM be changed to "Integrated MBA Course" of five years duration.

The Academic Council considered the above matter and **RESOLVED** that the nomenclature of BM-MAM be changed to "Integrated MBA Course" of five years duration and the existing admission procedures, scheme and syllabus of the dual Degree BM-MAM Programme be made applicable for the Integrated MBA Course(5 year).

18. Bachelor of Audiology and Speech Language Pathology (BASLP) - Internship – Approval of Institution – Consideration of – reg. (Ac.A.III)

As per the Regulations of BASLP Degree Course (Clause 12), each candidate has to undergo two semesters of internship (10 months) after successfully completing the course. Fifty percent of internship shall be done outside the parent institution approved by the University. Seven institutions have been listed as approved institutions for Internship of BASLP Degree Course vide U.O. No. Ac.AIII/3/FoM/IV-G-4/2012 dated 02.03.2013, as approved by the Academic Council dated 22.11.2012.

The Executive Director, NISH vide letter no. NISH/KU/BASLP/Int/2016-17 dated 01.06.2016 requested that National Institute for Physical Medicine and Rehabilitation (NIPMR), Irinjalakkuda, an organisation under the Govt. of Kerala may also be included in the list of approved centres for internship posting from July 2016. The former Chairman, Board of Studies in BASLP recommended that the National Institute for Physical Medicine and Rehabilitation (NIPMR), Irinjalakkuda be included as an approved institution for Internship of BASLP Degree Course and the Dean, Faculty of Medicine endorsed the said recommendation.

The Standing Committee of the Academic Council recommended to approve the proposal for including the National Institute for Physical Medicine and Rehabilitation (NIPMR), Irinjalakkuda in the list of approved centres for internship posting of BASLP Degree Course.

The Academic Council considered the above matter and **RESOLVED** to include the *National Institute for Physical Medicine and Rehabilitation (NIPMR), Irinjalakkuda* in the list of approved centres for internship posting of BASLP Degree Course.

19. Five Year Integrated MBA/Integrated BM-MAM programme – Mode of Valuation - Consideration of – reg. (Ac.A.IV)

The Five Year Integrated MBA programme/Integrated BM-MAM introduced from 2015 admissions consists of 10 semesters. After successful completion of first 6 semesters there is an exit point, in which the candidate shall be issued a Bachelor degree. After the successful completion of all the 10 semesters the candidate shall be awarded the Masters degree.

The Chairman, Board of Studies in Business Management (PG) clarified the mode of valuation of the answerscripts of the course and recommended that Single valuation mode may be followed. The Dean, Faculty of Management Studies remarked that single valuation is followed in all Graduate level programmes and Double valuation is followed in all Post Graduate Level programmes. Hence for the graduate portion of the programme for first 3 years (point of exit) single valuation can be made applicable and Post Graduate portion of programme (ie. last 2 years), double valuation may be made applicable, like other UG/PG programmes.

The Standing Committee of the Academic Council recommended to follow double valuation for the entire course work (Five years).

The Academic Council considered the above matter and **RESOLVED** to follow double valuation for the papers of the entire course (Five years) of the Integrated MBA Programme.

20. Recognition as Research Centre – Department of Electrical and Electronics Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram – Consideration of – reg. (Ac.E.I)

The Inspection Committee comprising Prof. M. Jamal Kunju, Sri. B.S.Jyothikumar (Members of the Syndicate) and Dr.B.Ajith Kumar, Head,Department of Electrical and Electronics Engineering, College of Engineering, Thiruvananthapuram (Subject Expert) conducted the Inspection of Department of Electrical and Electronics Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram on 23-09-2015 for its approval as research centre and recommended for starting Research and Doctoral Programmes in Department of Electrical and Electronics Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram. The Syndicate held on 20/06/2016 resolved that the Inspection report be placed before the Academic Council.

The Standing Committee of the Academic Council not recommended as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

The Academic Council considered the above matter and **RESOLVED** not to approve the Department of Electrical and Electronics Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram as a Research Centre of University of Kerala, as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

21. Recognition as Research Centre – Department of Mechanical Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram – Consideration of – reg. (Ac.E.I)

The Inspection Committee comprising Sri. B.S.Jyothikumar (Member of Syndicate) and Prof. Aswani Kumar, HoD, Department of Mechanical Engineering, College of Engineering, Thiruvananthapuram (Subject Expert) conducted the inspection of Department of Mechanical Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram on 23-09-2015 for its approval as research centre and recommended, that the Department of Mechanical Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram for recognition as an approved research centre of University of Kerala. The Syndicate held on 20-06-2016, vide Item No.18.69.A6 resolved that the Inspection report be placed before the Academic Council.

The Standing Committee of the Academic Council not recommended as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

The Academic Council considered the above matter and **RESOLVED** not to approve the Department of Mechanical Engineering, Government Engineering College, Barton Hill, Thiruvananthapuram as a Research Centre of University of Kerala, as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

22. Recognition as Research Centre – Department of Electronics and Communication Engineering, T.K.M.College of Engineering, Kollam – Consideration of - reg. (Ac.E.I)

The Inspection Committee comprising Dr.Rosamma Philip Prof.M.Jamal Kunju (Members of the Syndicate) and Dr.Vrinda.V.Nair, HoD, Department of Electronics and

Communication, CET, Kulathoor (Subject expert) conducted the inspection of Department of Electronics & Communication Engineering, TKM College of Engineering, Kollam on 17.10.2015 for the approval as research centre and the Inspection team recommended to approve the Department of Electronics and Communication Engineering, TKM College of Engineering, Kollam as research centre of University of Kerala. The Syndicate held 23.03.2016 (vide item No.16.58 A2) resolved that the Inspection report be placed before the Academic Council.

The Standing Committee of the Academic Council not recommended as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

The Academic Council considered the above matter and RESOLVED not to approve the Department of Electronics and Communication Engineering, TKM College of Engineering, Kollam as a Research Centre of University of Kerala, as the affiliation of the College stands shifted to KTU and Research Programmes are offered in the approved research centres under the KTU.

23. Recognition as Research Centre – Post Graduate Department of Physics, S.N.College for Women, Kollam – Inspection Report – Consideration of – reg. (Ac.E.VI)

The Principal, S.N.College for Women, Kollam (under Sree Narayana Trust) applied for recognition of the Department of Physics of the College as an approved research centre of the University of Kerala. The inspection committee comprising Prof. M. Jamal Kunju and Dr. Girish Kumar. R. (members of Syndicate) and Dr. V. Biju, HoD in charge, Department of Physics, University of Kerala, Kariavattom (Subject Expert), conducted the inspection at the Department of Physics, S.N.College for Women, Kollam on 28-11-2015. and recommended that Department of Physics, Sree Narayana College for Women, Kollam may be recognized as an approved research centre of University of Kerala on the subject of Physics. The Syndicate (Item No.B-40 of the appendix to item No.19.22) held on 16-07-2016 resolved that the Inspection report be placed before the Academic Council.

The Standing Committee of the Academic Council recommended to recognise PG Department of Physics, S.N. College for Women, Kollam as an approved Research Centre in Physics of the University of Kerala.

The Academic Council considered the above matter and **RESOLVED** to recognise the PG Department of Physics, S.N. College for Women, Kollam as an approved Research Centre in Physics of the University of Kerala.

24. Amendment to the Regulations relating to Recognition of Examinations and Degrees of State Boards/Statutory Universities/ Deemed Universities/Other Institutions – Consideration of - reg. (Ac.L)

The Degree/Diplomas awarded by other Universities/Institutions and recognized by the University of Kerala as approved by the Academic Council at its meeting held on 18.04.2016, have to be incorporated in the 'Regulations relating to Recognition of Examinations and Degrees of other Universities' by an amendment. The amendment to Regulations related to Recognition of Examinations and Degrees of other Universities laid before the Academic Council for consideration and adoption as envisaged under section 25(ii) of the Kerala University Act, 1974.

Amendment Proposal

"That, in Chapter IV- Norms for granting Recognition/ Equivalence to Examinations, Degrees etc., of Universities or Bodies of Foreign Countries of the Regulations relating to Recognition of Examinations and Degrees of other Universities, the following be added to the existing entries under relevant Universities/Institutions under the Heading "Degrees and Examinations of other Universities and institutions" recognized by the University of Kerala.

(List of Degrees /Examinations of other Universities/Institutions appended)

The Standing Committee of the Academic Council recommended to approve the Amendment proposal.

The Academic Council considered the above matter and **RESOLVED** to approve the above Amendment proposal, with the following correction:

In serial no.62 in the appendix, name of University be corrected as 'SRM University (Deemed) Kattamkulathur'.

25. Readmission to P.G courses under 2013 scheme semester pattern in affiliated colleges – carryover of marks of previous semesters – Consideration of - reg.

(Ac.A.II)

As per the existing Regulations of Re-admission to PG Degree programmes, candidates who discontinue the study under one Scheme & Syllabus when readmitted to another Scheme & Syllabus have to study in the current Scheme that is applicable at the time of readmission. There were two consecutive changes effected in pass criteria alone for postgraduate Degree programmes respectively from 2013 admissions and 2015 admission onwards resulting in the change of Scheme. In the meanwhile, the candidates readmitted during the period (2013 Admission) represented that the marks scored in their earlier semesters be retained on the ground that they had studied the same Syllabus.

The following draft proposal regarding readmission candidates recommended by the P.G Monitoring Committee held on 08^{th} September 2015 was considered by the Academic Council held on 19/10/2015 and resolved to refer the item to the Standing Committee of the Syndicate on Academics and Research.

1. The candidates who took readmission under the 2013 Scheme (ie from 2013 admission onwards).

In the case of candidates who took readmission under the 2013 scheme (ie from 2013 admission onwards) for subjects with the same syllabus as that of prior to 2013 admission but with different pass criteria, the committee recommended the following.

a.) The exams taken by such candidates prior to their readmission be brought on par with those from 2013 admission and they be governed by the rules and regulations for 2013 admission.

b.) The candidates shall surrender their mark lists for the semesters prior to their readmission for issuance of new marklists as per the Rules and Regulations for 2013 admission, and also, if required, to modify their results.

2. General Proposals

a.) Change in Syllabus only/Syllabus & Scheme: When a title of a paper changes or an additional paper has been introduced for any semesters prior to the readmission, in such cases the candidates shall complete their course and then attend the classes for the changed paper or additional paper. They shall be assessed internally and shall appear for the said papers. The marks of the other papers which have no change in title shall be carried forward. Such candidates shall be governed by the rules and regulations applicable for the year of readmission.

b.) Change in scheme only (With the same syllabus): The exams taken by the candidates prior to their readmission be brought on par with those from the changed scheme onwards and they shall be governed by the rules and regulations for the changed scheme (with the same syllabus). The candidates, if needed, shall surrender their marklists for the semesters prior to their readmission for issuance of new marklists as per the rules and regulations of the changed scheme and also, if require to modify their results.

As recommended by the Standing Committee of the Syndicate on Academics and Research held on 21.11.2015 the matter was placed before the combined meeting of the Standing Committee of the Syndicate on Academics and Research and Examinations and the Committee accepted the above recommendations of P.G Monitoring Committee held on 08.09.2015. In addition to the above recommendations, the Committee recommended (1) the failed candidates be permitted to avail chances up to March 2018 to a maximum of three chances (2) to release the result of those candidates who have appeared for the examination prior to 2013 scheme. The Syndicate held on 16.07.2016 approved the same.

The Standing Committee of the Academic Council recommended to refer the matter to the Boards of Studies & Faculty concerned for specific suggestions.

The Academic Council considered the above matter and **RESOLVED** to refer the matter to the Boards of Studies & Faculty concerned for specific suggestions.

26. B.Tech. Degree Course in Biotechnology and Biochemical Engineering (2008 Scheme) – Interchange of Credits for two subjects in the marklist of 3rd Semester – Consideration of - reg. (Ac.A.III)

The Academic Council at its meeting held on 19th May, 2015 considered the matter of interchange of credits for 2 subjects 08.303 'Cellular and Organismal Biology (4 credits) and 08.306 ;Micro biology; (3 credits) noted in the marklist of 3rd semester B.Tech. Degree Examination of Biotechnology and Biochemical Engineering (whereas it is 3 credits for 08.303 and 4 credits for 08.306 in the scheme) and resolved that modified marklist incorporating the corrections be issued to the present and passed out students, as recommended by the BoS in Engineering (Pass I, II & III) and endorsed by the Faculty of Engineering & Technology.

The tabulation section pointed out the practical difficulties in issuing modified marklist to the students who attended the Regular (five batches) and supplementary examinations which would lead to a change in the GPA of 3rd semester and CGPA of 8th semester on consolidation of the final marklists. The change in CGPA causes change in classification of results and the Degree certificates issued may have to be cancelled. The transcripts, attestations and genuineness reports issued already will also be affected.

The Chairman, BoS in Engineering (Pass II) considered the possibility of changing the credits in the scheme (2008) as per the credits noted in the marklist viz. 08.303 Cellular and Organismal Biology with credits 4 and 08.306 Microbiology with Credits 3 so that the certified documents maintained/released remain unchanged.

The Chairman, Board of Studies in Engineering (Pass II), in consultation with the subject expert remarked that as five batches of students have already completed their course and issued with marklist indicating the interchanged credits, it would be difficult and impractical to correct the marklist already issued. Hence recommended that the discrepancy of credits may be avoided by making appropriate changes in the scheme and syllabus of 3rd semester B.Tech. Biotechnology and Biochemical Engineering course and bring parity between the credits of the subjects 08.303 Cellular and Organismal Biology (4 credits) and 08.306 Microbiology (3 credits).The recommendation of the Chairman, BoS in Engineering (Pass II) was endorsed by the Dean, Faculty of Engineering & Technology.

The Standing Committee of the Academic Council recommended to accept in principle and corrective steps be taken individually on receipt of request in writing from the candidates.

The Academic Council considered the above matter and **RESOLVED** that appropriate changes in the scheme(2008) and syllabus of 3^{rd} semester B.Tech. Biotechnology and Biochemical Engineering course be effected to bring parity between the credits of the subjects 08.303 Cellular and Organismal Biology (4 credits) and 08.306 Microbiology (3 credits) in the marklists already issued and the Scheme and Syllabus.

27. Recognition of B.A.Programme in Economics (Regular) awarded by University of Delhi – Request of Smt. Athira. P.V. - Consideration of – reg. (Ac.C)

Smt. Athira. P.V., applied for course recognition of the B.A.Programme in Economics (Regular) awarded by the University of Delhi for the purpose of admission to M.A.Economics course.

The Chairman, Board of Studies in Economics (Pass) recommended to grant recognition to the B.A. Programme in Economics (Regular) awarded by the University of Delhi as equivalent to B.A.Economics degree of the University of Kerala for higher studies and employment and the Dean, Faculty of Social Science endorsed the said recommendation.

The Standing Committee of the Academic Council recommended to recognise B.A. Degree Programme in Economics (Regular) awarded by University of Delhi as equivalent to B.A. Economics Degree of the University of Kerala.

The Chairperson, Board of Studies in Commerce (Pass) recommended to grant recognition to the B.Com. Degree (Distance) awarded by the Bharathiar University for higher studies and employment. The Dean, Faculty of Commerce endorsed the said recommendation.

The Standing Committee of the Academic Council recommended to recognise B.Com. Degree through Distance Education awarded by Bharathiar University, Coimbatore, as equivalent to B.Com. Degree of the University of Kerala.

The Academic Council considered the above matter and **RESOLVED to** recognise the B.Com. Degree through Distance Education awarded by Bharathiar University, Coimbatore, as equivalent to B.Com. Degree (Distance) of the University of Kerala.

29. Recognition of B.Sc. Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed) - Request from Smt. Sneha Mohan – Consideration of – reg. (Ac.C)

Smt.Sneha Mohan applied for course recognition of the B.Sc.Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed) for the purpose of higher studies (Admission to M.C.A programme of the University of Kerala).

The Chairman, Board of Studies in Computer Science (Pass) remarked that the whole matter be placed before the BoS in Computer Science (Pass) for taking a final decision, since as per the Eligibility Criteria for admission to the B.Sc.Degree in Computer Science (Regular) course offered by Amritha Vishwa Vidyapeetham University (Deemed), Mathematics is not mentioned as mandatory. The candidate has studied Mathematics at Plus Two level.

The additional meeting of the Board of Studies in Computer Science (Pass) at its meeting held on 14/06/2016 vide Item No. II (d) considered the matter regarding recognition of the B.Sc.Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed). and remarked that according to the regulation of the University of Kerala, Mathematics is one of the mandatory subject of study at Higher Secondary level. But the

eligibility condition of the Amritha Vishwa Vidyapeetham University does not consider Mathematics as a mandatory subject at the Higher Secondary level. So the Eligibility cannot be granted.

As per U.O.No.Ac.C/35575/2007dated 10/06/2010 issued earlier, the Academic Coucil at its meeting held on 25/05/2010 vide item No.33 had resolved that the courses offered by Amritha Vishwa Vidyapeetham University (Deemed) be recognized as equivalent to the courses of the University of Kerala. Until and unless such a U.O is revoked, we cannot deny granting of recognition to the B.Sc.Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed), even if the reasons quoted by the Board of Studies in Computer Science (Pass) are found genuine.

The Dean, Faculty of Applied science and technology offered remarks as noted:

- 1. The Academic Council Decision dated 25/05/2010 embodied in U.O.No.Ac.C/ 335575/2007 dated 10/06/2010. over-rides the B.O.S decision not to grant recognition.
- 2. Recommended to grant recognition to the B.Sc. Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed) for the purpose of admission to M.C.A Degree of the University of Kerala and for employment purposes.

The Standing Committee of the Academic Council recommended to recognise B.Sc. Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed) as eligible qualification for higher studies in the field of Computer Science.

The Academic Council considered the above matter and **RESOLVED** to recognize the B.Sc. Degree in Computer Science (Regular) awarded by Amritha Vishwa Vidyapeetham University (Deemed) as an eligible qualification for higher studies in the field of Computer Science, provided the candidate has studied Mathematics at the Plus- 2 level.

Further RESOLVED to revoke the U.O.Ac.C/335575/2007 dated 10/06/2010.

The additional meeting of the Board of Studies in Computer Science(Pass) held on 14/06/2016 vide item No.II(b) considered the matter of recognition and decided not to recognize the degree, as according to the regulation of the University of Kerala, eligibility Condition of the Autonomous College (Sri Krishna Arts and Science College (Autonomous) does not consider Mathematics as a mandatory subject at the Higher Secondary Level. The Dean, Faculty of Applied Science and Technology remarked that "the matter has not been disposed by the Board of Studies after exhausting the application of all provisions, nor is the decision articulated clearly (i.e, general recognition/specific equivalence)". Further remarked that the Board of Studies may re-consider the matter and decide whether the B.Sc.Degree in Computer Technology of Bharathiar University through Sri Krishna Arts and Science College (Autonomous), Coimbatore can be recognized for the purpose of admission to MBA.

As there is a difference in the admission criteria, not recommended to grant recognition to the said course. The Dean remarked that recognition can be given for the purpose of admission to higher studies.

The Academic Council held on 18th April 2016 vide item No.05 resolved that the item be referred to the Board of Studies in Computer Science (Pass) owing to the difference of opinion between Chairman, Board of Studies in Computer Science (Pass) and Dean, Faculty of Applied Sciences and Technology.

The revised scheme and syllabus for First Degree Programme in Chemistry under CBCS system was implemented with effect from 2013 admissions. Micro-scale method of Analysis and Two burette titration method was introduced for all lab courses in Chemistry after conducting training workshop for teachers and the Academic Council approved the same.

The Chairman, Board of Studies in Chemistry (Pass) based on the requests from Colleges pointing out the practical difficulties in conducting the practicals as per the two burette titration method, recommended to follow conventional method in Volumetric Analysis for certain experiments in V semester B.Sc Chemistry (Core) Practicals and the Academic Council held on 18-04-2016 approved the recommendations and U.O.No.Ac.AV/1/45047/2015 dated 17-11-2015 issued.

The Chairman, Board of Studies in Chemistry (Pass) again recommended to follow conventional method in Core and Complementary Practicals for all courses in Chemistry citing the anomalies and short comings reported from various colleges about the newly introduced two burette titration for B Sc Chemistry Core and Complementary Courses and the matter was placed before the Board of Studies in Chemistry (Pass) held on 29-07-2016 and the Board recommended the following:

59. Two year M.Ed Curriculum (2015 scheme) – Modifications in the Regulations -Approval of - Consideration of - reg. (Ac.A.III)

The tabulation section sought clarification regarding the Examination and pass minimum of internal assessment of the various components of two year M.Ed Degree Course (2015 scheme). The Chairperson, Board of Studies in Education (PG) offered the following recommendations for incorporating in the second para of **Clause (g)**, of the Regulations (pages 15 & 16)

- 1. For Internship (INT1), there has to be a pass minimum of 50%. This mark shall be given by the Head of the Institution in consultation with the concerned Teacher/ Teachers in charge of Internship.
- 2. For research proposal, 25 marks each has been allotted for external and internal. The student shall get a pass minimum of 50% in the external as well as internal i.e., 12.5 each.
- 3. For dissertation and viva-voce (DIS1) also, a pass minimum of 50% is needed .i.e., an aggregate 100 out of 200 for dissertation and 25 out of 50 for viva voce is needed for a pass.
- 4. For Internship 2 (INT2) also, a pass minimum of 50% is needed. i.e. the candidate should secure 25 out of 50 for a pass. This mark shall be given by the Head of the Institution in consultation with the concerned Teacher/Teachers in charge of Internship.
- 5. For a pass in the examination, a candidate should secure a minimum of 50% marks in aggregate with a minimum of 40% in each theory paper in the external examinations of the University. There is no pass minimum for CE for the core and elective papers.

- 6. A candidate may be permitted three more chances other than the regular chance to enable the candidate to complete the course.
- 7. A candidate has to reappear for the failed paper or papers only and shall obtain minimum 50% marks for ESA for each failed paper, for a pass in that paper.

The above recommendations of the Chairperson were endorsed by the Dean, Faculty of Education.

The Standing Committee of the Academic Council recommended to approve the proposals of the Chairperson, BoS in Education (PG), as endorsed by the Dean, Faculty of Education.

Sri. Amith Krishnan. H., passed Plus 2 course from Kendriya Vidyalaya, Pattom with Biotechnology as one of the subject. The candidate has studied Physics, Chemistry and Mathematics as optional subjects.

The eligibility criteria for B.Sc. Biotechnology is "A pass in Higher Secondary Examination of the State or an Examination accepted by the University as equivalent thereto with Biology as one of the subjects".

The Chairman, Board of Studies in Biotechnology (Pass) remarked that a student who has studied science group (Physics, Chemistry and Mathematics) with Biotechnology as one of the subjects is eligible for admission to B.Sc. Biotechnology. The above remarks were also endorsed by the Dean, Faculty of Applied Science and Technology.

The Vice-Chancellor, subject to reporting to the Academic Council, approved the recommendations of the Chairman, Board of Studies in Biotechnology (Pass) as endorsed by the Dean, Faculty of Applied Sciences and Technology that the students who have passed Senior Secondary Examination with Science Group (Physics, Chemistry and Mathematics) with

Biotechnology as one of the subjects is eligible for admission to the B.Sc. Biotechnology degree course and U.O. No.Ac.AIV/3/B.Sc Biotechnology/2016 Dated 08.06.2016 issued in this regard.

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted the action taken by the Vice-Chancellor.

62. B.A. Honours Degree course in English Language and Literature for admission to M.A Degree course in English Language and Literature - Weightage - Approved Orders - reporting of – reg. (Ac.A.II)

The Scheme and Syllabus of B.A. Honours Degree in English Language and Literature was approved and implemented with effect from 2013 admissions.

The Co-ordinator, B.A English (Honours) programme, University of Kerala and students of the college have made representations to the University for creating additional seats for M.A English course in select colleges viz, Government Arts College, College for Women and University College, Thiruvananthapuram for admitting B.A Honours students considering disadvantages faced by these students in terms of the course contents which is rather tough compared to the regular B.A English Language and Literature course and also regarding the final score.

The Chairman, Board of Studies in English (PG) who is also the Dean, Faculty of Arts recommended that a weightage of 5% which would translate to a maximum of 40 marks, may be given to the students of the B.A English (Honours) programme of the Government College for Women, Thiruvananthapuram for the calculation of index marks for admission to the M.A English Degree course of the University of Kerala.

The Vice-Chancellor, subject to reporting of the Academic Council, approved for giving weightage of marks to the students of B.A Honours for admission to M.A Degree course in English and U.O No.Ac.A.II/1/2016 dated 17.08.2016 was issued in this regard.

The Chairman, Board of Studies in Statistics (Pass) while clarifying the consolidation of results of 6th semester recommended that the consolidation of marks for Practical courses (Written and Lab) of 6th semester (2013 admissions) should be done in the same way as that of consolidation of marks in 4th semester practicals. The same book is recommended for the Foundation Course 1: 'Writings on Contemporary Issues' [CG 1121.3] of BA English and Communicative English from 2016 admission onwards. Clause (7): "A candidate will be considered to have satisfactory attendance if she/he earns not less than 75% attendance for theory classes and 90% for school internship. Six point grade system is followed in rating attendance. Attendance will be noted in letter grades in the mark list. The attendance range and respective grades are as follows: Gr: A+ (95 to 100%), Gr: A (90 to < 95%), Gr: B+ (85 to < 90%), Gr: B (80 to < 85%), Gr: C+ (75 to < 80%) Gr: C (below 75). (For calculating percentage of attendance decimals will be rounded to the nearest whole number)".

Clause 15: "If a candidate wants to improve his/her grade he/she can appear for the theory examination and improve the grades for the first and second semesters in the next immediate chance, if the same scheme exists".

Clause 16: "Improvement is limited to theory paper alone. For improvement in theory, candidates have to appear for the concerned examinations with the regular schedule. Higher marks of the two ie., marks before betterment and after betterment whichever is higher will be considered".

The Vice-Chancellor, subject to reporting to the Academic Council approved the above modifications in the Regulations as recommended by the Former Chairman, Board of Studies in Education (Pass) and the Dean, Faculty of Education and U.O.No.Ac.A.III/2/B.Ed/ 2016 dated 19/07/2016 was issued in this regard.

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted the action taken by the Vice-Chancellor.

67. Two year B.Ed Degree in Special Education (Intellectual Disability) 2015 scheme - Modification in the Regulations – Action taken – Reporting of – reg. (Ac.A.III) The tabulation section sought clarifications on Pass minimum of the internals of the two

year B.Ed Degree in Special Education. In the absence of the Board of Studies in Education (Pass) a special meeting of the former Chairman, Board of Studies in Education (Pass) and the Dean, Faculty of Education was held on 23/06/2016 to discuss the clarification sought and it was recommended to incorporate the following to the existing Clause XVII (Pass Minimum) in the Regulations of two year B.Ed Degree Course in Special Education (Intellectual Disability).

68. B.Ed Curriculum 2013 – Finalisation of result - Clarification – Action taken – Reporting of – reg. (Ac.A.III)

Curriculum 2013 (page no. 4) as: "For a pass in the examination, a candidate should secure a minimum of 50% marks ('C+' or 'C' Grade) in aggregate with a minimum of 40% (C Grade) in each Theory Paper in the external examination of the University, 40% for Theory and CE taken together in each paper; and 50% (C+ Grade) for Practice-teaching in the Second Semester. There is no minimum for CE and other Practical Courses have to be given to various categories on the basis of proper guidelines and criteria. Detailed records have to be maintained by institutions in each case".

The tabulation Section sought further clarification on finalisation of result of candidates found to have obtained 50% marks but with D grade. The former Chairman, Board of Studies in Education (Pass) remarked that irrespective of the aggregate grade, a candidate can be declared to have passed the B.Ed. Degree Examination if he/she has secured 50% marks and satisfies all other conditions, and the same has been endorsed by the Dean, Faculty of Education.

The Vice-Chancellor, subject to reporting to the Academic Council, approved the above recommendation of the former Chairman, Board of Studies in Education (Pass) as endorsed by the Dean, Faculty of Education.

The Standing Committee of the Academic Council recommended to note the action reported.

The University had discontinued Private Registration for PG courses and offered PG programmes through the School of Distance Education from 2002 admission onwards vide U.O.No.Ac.A.IV/1/019086/2002 dated 23.07.2002. Consequent to the withdrawal of recognition of the courses of SDE for the academic year 2015-16 by the UGC, the Syndicate held on 14.12.2015 resolved that the UG/PG programmes which do not require laboratory facilities be offered under private registration. Since the existing Regulations for PG courses were not suitable for offering PG courses under private registration, the Academic Council held on 18.04.2016 resolved to entrust Standing Committee of the Academic Council for preparing the Regulations of the Post Graduate programmes under the annual pattern to be offered under private registration mode. The Standing Committee of the Academic Council held on 20.05.2016 considered the draft regulation and recommended to approve the draft regulations applicable to the PG courses under annual pattern feasible for private registration mode.

The Vice Chancellor approved the Regulations for the PG courses under annual pattern feasible for private registration mode, subject to reporting to the Academic Council.

The Standing Committee of the Academic Council recommended to note the action reported.

79. Dissertation and Internship of IV Semester of M.A. Degree course in Mass Communication and Journalism preparation and evaluation procedure - Approved orders - issued - reporting of – reg. (Ac.A.II)

The Scheme and Syllabus of M.A Degree course in Mass Communication and Journalism was approved and implemented with effect from 2015 admissions. The PG Tabulation section sought clarifications in respect of Dissertation and Internship included in the IV Semester of M.A Degree course in Mass Communication and Journalism.

The Chairman Board of studies in Communication Journalism clarified that there shall be two Viva- voce examinations for the MMCJ Programme - one based on the dissertation (core course 15) and another covering the whole MMCJ Programme (Core course 16), including the internship report. But these two examinations shall be conducted simultaneously by a 3-member Board of Examiners, appointed by the University. Maximum marks for these courses shall be 100 marks each. There is no continuous assessment for these courses.

The amended parts of the course structure and scheme of examination of the Master of Mass Communication and Journalism (MMCJ) are given below:

Dissertation

Each student is required to submit a dissertation based on any topic of his/her interest in the area of mass communication and Journalism, in the Fourth semester of MMCJ Programme. This project is aimed at introducing the students to the fundamental aspects of media research methodology. Students shall discuss the feasibility of their dissertation project with the Faculty members and submit a brief statement of the chosen topic to the Head of the Department. The students are required to get a formal approval of their topics from the Departments Faculty Council. Each student shall be guided by a Faculty member. The dissertations should be submitted to the HOD on or before the last working day of fourth semester. A three member Board of Examiners appointed by the University shall evaluate the dissertations and award marks. The split-up of marks for dissertation shall be

(a) Quality of dissertation - 80 marks

(b) Viva-voce examination based on the dissertation - 20 marks

The Viva-voce examination for the dissertation (MMCJ 15) and the Comprehensive viva-voce examination (MMCJ 16) shall be conducted simultaneously by a 3 member BoE appointed by the University.

<u>Internship</u>

The students are required to do an internship for a period of 30 days in an accredited media organisation at the end of the fourth semester. Each student has to prepare a detailed report of his/her internship in the media organisation and it may be certified by the head of the media organisation. The certified internship report should be submitted to the HOD before the Vivavoce examination.

Comprehensive Viva Voce

Comprehensive Viva Voce Examination shall be conducted at the end of the fourth semester covering the whole MMCJ Programme, including the internship report. The split-up of marks for the comprehensive viva-voce examinations shall be.

(a) Viva covering the whole programme - 60 marks.

(b) Internship report - 40 marks

The Board of Examiners appointed by the University shall also evaluate the MMCJ dissertations and conduct a viva voce examination based on the dissertation of each student, along with the comprehensive viva voce examinations of the MMCJ Programme (Page No. 3 of the Syllabus).

The Vice-Chancellor, subject to reporting to the Academic Council, approved the preparation and evaluation procedures of the Dissertation and Internship included in the IV Semester of M.A Degree course in Mass Communication and Journalism as recommended by the Board of Studies in Communication and Journalism and as endorsed by the Dean, Faculty of Arts.

The Standing Committee of the Academic Council recommended to note the action reported.

80. B.Arch/M.Arch/M.Planning Degree Courses – Students of this University who discontinue the course – Readmission under KTU – Sanctioned – Reporting of – reg. (Ac.A.III)

As approved by the Academic Council, the students of B.Tech. and M.Tech. courses of this University who discontinued their course were permitted to join the regular batch affiliated to KTU, subject to the norms of KTU. As Architecture related courses have been shifted to KTU with effect from 2016 admission, remarks of KTU was sought on admitting the students of B.Arch/M.Arch/M.Planning courses of this University with shortage of attendance in a semester to the regular batch of KTU. The Director (Academic) KTU informed that the conditions for applicable to and M.Tech. readmission B.Tech. Programmes are extended to B.Arch/M.Arch/M.Planning Programmes also.

The Vice-Chancellor subject to reporting to the Academic Council accorded sanction to extend the provision for readmission under KTU applicable to B.Tech. and M.Tech. students of this University, to the students of B.Arch/M.Arch/M.Planning Programmes also.

The Standing Committee of the Academic Council recommended to note the action reported.

81. Regulations for Award of M.Phil Degrees, University of Kerala 2016 – Approved -Reporting of – reg. (Ac.A.II)

The University Grants Commission, notified the U.G.C (Minimum Standards and Procedures for Award of M.Phil/Ph.D Degree) Regulations, 2016 in the Gazette of India. The Regulations, as specified therein, shall come into force on the date of their publication in the Gazette of India and stands applicable to every University established or incorporated by or under the Central Act, Provincial Act or a State Act, every Institution including the constituent of an affiliated college recognized by the Commission in consultation with the University concerned under Section 3 of the University Grants Commission Act, 1956.

Sanction was accorded by the Vice-Chancellor, to the UGC Regulations 2016, being implemented w.e.f 05.07.2016 subject to reporting to the Academic Council as per the U.O No.Ac.E1/10685/2016 dated 20.07.2016.

The Standing Committee of the Academic Council framed the draft Regulations for Award of M.Phil Degrees, University of Kerala, 2016 separately, in line with the UGC Regulations, 2016 and recommended to approve and implement the same.

The Vice Chancellor, in exercise of the powers conferred under Section 10 (13) of the Kerala University Act, 1974, approved the Regulations for award of M.Phil Degree, University of Kerala 2016 being implemented in the University with effect from 05.07.2016 and U.O No.Ac.A.II/2016 dated 20.08.2016 was issued in this regard.

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted the action taken by the Vice-Chancellor. Further **RESOLVED** to constitute a sub-committee comprising the Vice-Chancellor, the Pro Vice-Chancellor, Deans of Faculties, Dr.R.Lathadevi, Prof.R.Mohanakrishnan, Sri.B.S.Jyothikumar, Dr.P.Rajeshkumar, Dr.P.M.Radhamany (Members, Syndicate), Dr.M.S.Vinayachandran, Member, Academic Council and University Union General Secretary to consider matters relating to Research.

82. UGC Regulations 2010 – 2nd, 3rd and 4th Amendments – Implemented – U.Os issued – Reporting of – reg. (Ac.F.II)

The University Grants Commission had brought in the 2nd, 3rd and 4th amendments to the Principal UGC Regulations 2010 vide notifications dated 13th June 2013, 4th May 2016 and 11th July, 2016 respectively. The above amendments were implemented in the University by the Vice-Chancellor in exercise of the powers vested upon him under Section 10(13) of Kerala University Act, 1974, except the amendment regarding the direct teaching hours and the weightage to be given to different levels of teachers provided under Table I of Appendix III as contained in the 3rd and 4th Amendment, which shall be implemented subject to the concurrence of the Government. University Orders in connection with these Amendments were issued vide U.O.No.Ac.F.II/General/UGC-R.2010/2014 dated 18/11/2015, U.O.No.Ac.F.II/General/UGC-R.2010/2016 dated 16/7/2016, U.O.No.Ac.F.II/General/UGC-R.2010/2016 dated 20/07/2016.

The Standing Committee of the Academic Council recommended to note the action reported.

83. Registration to Ph.D – adoption of – UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree), Regulations, 2009 – Reporting of – reg. (Ac.E.I) The University Grants Commission notified the UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree), Regulations, 2009 in the Gazette of India dated 28.07.2011. The Regulations, as specified therein, shall come into force with the date of their publication in the Gazette of India and stands applicable to every University established or incorporated by or under the Central Act, Provincial Act or a State Act, every Institution including the constituent of an affiliated college recognized by the Commission in consultation with the University concerned under Clause (1) of Section 2 of the University Grants Commission Act, 1956 and every Institution deemed to be a University under Section 3 of the said Act.

The UGC vide letter dated 06.07.2015 addressed to the Vice-Chancellor, issued the following clarifications with regard to the appointment of Research Supervisors, reminding that any violation will be viewed very seriously by the UGC.

'Universities shall allocate the Supervisor from amongst the regular faculty members in a Department or its affiliated PG Colleges/Institutes depending on the number of students per faculty member, the available specialization among the faculty supervisors and the research interest of the student. It is further clarified that any Ph.D/M.Phil Degree awarded by a University under the supervision of a supervisor who is not a faculty member of the University or its affiliated PG Colleges/Institutes would be in violation of UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree) Regulations, 2009.'

The UGC vide their letter dated 04.09.2015 reiterated the above directions as it has come to the notice of the UGC, as stated, that some of the Universities are circumventing the provisions of UGC Regulations, 2009. It was also strictly mentioned therein that in case of any aberration by the University it will be proceeded against as per the UGC Act, 1956 and the name of the University will be put in the defaulters list on the UGC website.

The University vide letter dated 03.11.2015 addressed the UGC seeking relaxations to the provision in the UGC Regulations 2009, as resolved by the last Academic Council. The Vice-Chancellor in person approached the Chairman-UGC on 13.11.2015 with a copy of the letter dated 03.11.2015 sent to the UGC Chairman and on briefing the contents, the Chairman reiterated the implementation of the general directions given in common to all Universities in the Country with no exceptions to any individual Universities.

It was further informed that the UGC cannot respond to the queries or consider relaxations sought by the individual Universities, as all are bound to implement the UGC regulations, 2009, in toto. No relaxation has been granted by the UGC.

In the above circumstances, sanction was accorded by the Hon'ble Vice-Chancellor in exercise of the powers of the Academic Council vested under section 10(13) of the Kerala University Act 1974 to the following, in consonance with UGC Regulations 2009, and the subsequent clarifications issued by the UGC. (U.O.No.Ac.E.I./2015 dated 8.1.2016 has been issued).

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted the action taken by the Vice-Chancellor.

84. Registration to Ph.D. – UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree) Regulations, 2016 – Adoption and approval of Regulations for the Award of Ph.D.Degrees, University of Kerala, 2016 – Reporting of - reg. (Ac.E.I)

The University Grants Commission, notified the UGC (Minimum Standards and Procedures for Award of M.Phil/Ph.D. Degree) Regulations, 2016 in the Gazette of India. The Regulations, as specified therein, shall come into force on the date of their publication in the Gazette of India and stands applicable to every University established or incorporated by or under the Central Act, Provincial Act or a State Act, every Institution including the constituent of an affiliated college recognized by the Commission in consultation with the University concerned under Section 3 of the University Grants Commission Act, 1956.

Sanction has been accorded by the Vice-Chancellor, to the UGC Regulations 2016, being implemented w.e.f. 05/07/2016 subject to reporting to the Academic Council and the U.O No. AcE1/10685/2016 dated 20/07/2016 has been issued.

The Standing Committee of the Academic Council held on 6/8/2016 vide item No:1 framed the draft regulations for the award of Ph.D Degrees, University of Kerala, 2016 in line with the UGC Regulations 2016 and recommended to approve and implement the same.

The Vice Chancellor in exercise of the powers conferred under section 10 (13) of the Kerala University Act, 1974, approved the Regulations, for award of Ph.D Degrees, University of Kerala 2016 being implemented in the University w.e.f 05/07/2016 and a U.O. No.Ac.E.I/10685(1) 2016 dated 12-8-2016 issued.

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted the action taken by the Vice-Chancellor.

85. University Post Doctoral Fellowship – modified Regulation for the award of University Post Doctoral Fellowship – Issuance of University Order – Reporting of – reg. (Ac.E.VII)

The rules followed at present for the award of University Post Doctoral Fellowship were formulated on the basis of recommendation of joint meeting of the Standing Committee on Research and Scholarships, the Dean's of Faculties and Heads of the Department held on 04/11/1986 and the amendments thereof approved by the Syndicate.

Considering the importance attached to Post Doctoral Research by the UGC in appointments to the teaching positions, it was found imperative to streamline the procedures and to formulate comprehensive regulations for award of the University Post Doctoral Fellowship. The matter was considered in the sixth meeting of the IQAC held on 30-09-2015 and resolved to refer it to the Standing Committee of the Academic Council for appropriate suggestions.

The Standing Committee of the Academic Council held on 18-02-2016 entrusted the Core Committee of the Standing Committee of the Academic Council to prepare & submit specific proposals and guidelines. The draft regulation framed by the Core Committee was placed before the Standing Committee of the Academic Council held on 20-05-2016 and it was recommended to approve the Regulations.

The Vice-Chancellor, subject to reporting to the Academic Council approved the Regulations and a University Order implementing the Regulation for the award of University Post Doctoral Fellowship was issued vide University Order No.Ac.E.VII/2016 dated 31/05/2016.

The Standing Committee of the Academic Council recommended to note the action reported.

86. 'Paper Published in National/International Seminar or Conferences peer reviewed proceedings may be considered as a publication in the Standard Journal'- reporting of – reg. (Ac.A.II)

The Academic Council at its meeting held on 19th May 2015, approved the proposal to update the list of standard journals in Linguistics as recommended by the Board of Studies in Linguistics and as endorsed by the Faculty of Oriental Studies and U.O No. Ac. AII/3/12847/Std.journals/2015 dated 30.06.2015 was issued in this regard. As part of the Faculty minutes, the Academic Council approved the recommendation of the Board of Studies in Linguistics that the papers published in National/International Seminar or conferences Peer reviewed proceedings also be considered as a Publication in standard journals.

Dr.S.A.Shanavas, Head of Department, Department of Linguistics, requested to modify the above said U.O in the above lines incorporating the recommendation of the Board of Studies in Linguistics, which states that, the papers published in National/International Seminar or conferences Peer reviewed proceedings be considered as a Publication in standard journals.

University Orders on updation /addition of standard journal never include a general Clause as stated above and instead, the order of updation/addition of journals contains only the list of journals with their ISSN Number and the name of Publisher. The above clause states that 'Paper Published in National/International Seminar or Conferences peer reviewed proceedings may be considered as a publication in the Standard Journal'. It may be noted that there is no benchmark, as of now, to see whether Seminars/Conferences are National or International. Going by the guidelines of the UGC on API Score, it is found that the two components viz., Research works published in the Referred journals and papers presented in conference/Seminars published in the form of proceedings as full papers are treated distinctively carrying different weights.

The Standing Committee of the Academic Council recommended to note the action reported. The Academic Council considered the above matter and **RESOLVED** to defer the matter to the next meeting of the Academic Council.

87. Faculty of Engineering & Technology – Minutes of the additional meeting held on 16.06.2016 – Approved by the Vice-Chancellor – Reporting of – reg. (Ac.A.III)

The Minutes of the additional meeting of the Faculty of Engineering & Technology held on 16.06.2016 was approved by the Vice-Chancellor, subject to reporting to the Academic Council. U.O.No.Ac.A.III/4/Engg/Tech/2016 dtd.24.06.2016 on Item No.1 issued and action taken on the other items.

The Standing Committee of the Academic Council recommended to note the action reported.The Academic Council noted the action taken by the Vice-Chancellor.

88. Private Registration to B.A - Repetition of Subsidiary Subjects – Consideration of reg. (Ac.A.II)

Requests received from candidates who have cancelled their B.A Degree examination and registration which they have undergone either through private registration or distance mode under annual pattern for permission to choose a different set of optional subjects which include the subjects earlier chosen by them either as Main/Subsidiary subjects. As per the existing provisions, repetition of subjects (either main or subsidiary) is not allowed in the new set of optionals chosen by such candidates. The requests have been made on the ground that the subjects earlier chosen has no relevance since both the examination and registration are cancelled before submitting application for fresh registration.

The Standing Committee of the Academic Council recommended that the candidates seeking fresh registration to B.A. Courses after cancelling the examination and registration (in private mode or distance mode under annual pattern) be permitted to choose a set of new optional subjects regardless of the subjects of study in respect of Main/Subsidiary Subjects. Further recommended that this provision be made applicable from 2017 -18 academic year onwards.

The Academic Council considered the above matter and **RESOLVED** that candidates seeking fresh registration to B.A. Courses after cancelling the examination and registration (in private mode or distance mode under annual pattern) be permitted to choose a set of new optional subjects regardless of the subjects of study in respect of Main/Subsidiary Subjects chosen originally.

Further **RESOLVED** that this provision be made applicable with effect from the academic year 2017-18.

89. The additional weightage of 5% to the B.A (Hon) candidates in affiliated Colleges – Consideration of – reg. (Ac.A.II)

The Co-ordinator, B.A English (Honours) Programme, University of Kerala and the students of the college made representations to the University for creating additional seats for M.A English course for B.A Honours students considering the disadvantages faced by these Students in terms of the course contents which is rather tough compared to the regular B.A English Language and Literature course and also giving regard to the final scores, which are comparatively low.

The Online Admission Monitoring Committee for UG-PG admission at its meeting held on 04.06.2016 discussed the issue and recommended to obtain specific remarks from the Chairman, Board of Studies in English (PG) and it was recommended that a weightage of 5% of total marks secured for the English main Papers which would translate to a maximum of 40 marks, may be given to the candidates of B.A English (Hon) Programme of the Government College for Women, Thiruvananthapuram for the calculation of index marks for admission to the M.A. Degree Programme of the University of Kerala.

The Standing Committee of the Academic Council, held on 22.07.2016, considered the matter and recommended to approve the proposal of the Chairman, BOS in English (PG), subject to reporting to the Academic Council. The Vice-Chancellor approved the recommendation and U.O No.Ac.II/1/2016 dated 17.08.2016 issued.

The Standing Committee of the Academic Council recommended to note the action reported. Further recommended that the same be extended for admissions in the Institute of English also from 2017 admissions onwards, subject to the concurrence of the CSS Academic Committee.

The Academic Council considered the above matter and **RESOLVED** to approve the action taken by the Vice- Chancellor in having granted weightage of 5% of total marks secured for the English main Papers which would translate to a maximum of 40 marks, to the candidates of B.A English (Hon) Programme for the calculation of index marks for admission to the M.A Degree Programme of the University of Kerala.

Further **RESOLVED** that the above provision be extended for admissions in the Institute of English also from 2017 admissions onwards, subject to the recommendations of the CSS Academic Committee.

90. The Syllabus of B.L.I.Sc. course under regular mode through affiliated colleges reporting of - reg. (Ac.A.II)

White Memorial College of Arts and Science for Women, Panachamoodu was permitted to offer B.L.I.Sc. course of one year duration from the Academic year 2015-16. Subsequently, the Principal sought permission to offer the course under the existing Syllabus from 2016-17 onwards, as there were no intake during 2015-16.

The Chairman Board of Studies in Library and Information Science, recommended that, the college be permitted to start offering the Bachelors Degree in Library and Information Science (B.L.I.Sc.) course of one year duration based on the existing syllabus U.O. No.Ac.AII/2/30862(10)/B.L.I.Sc, M.L.I.Sc./2012 Dated 23.06.2012 and that the one year course is meant for graduates in any discipline obtained from any University recognized by the University of Kerala and the Dean, Faculty of Arts endorsed the remarks of the Chairman, Board of Studies in Library and Information Science.

The Vice-Chancellor, subject to reporting to the Academic Council, approved the recommendation of the Standing Committee of Academic Council and U.O.No.Ac.A.II/4/ B.L.I.Sc/2016 dated 07.09.2016 was issued in this regard.

The Standing Committee of the Academic Council recommended to note the action reported.

The Academic Council noted	the action taken by the Vice-Chancellor.

91. Starting of the Post-Graduate Diploma course in Technical Communication (E-learning mode) – Scheme and Syllabus – approval – Consideration of – reg. (Ac.A.II)

The additional meeting of the Board of Studies in Library and Information Science held on 16.04.2016 recommended to approve the Syllabus of the course Post-Graduate Diploma in Technical Communication (E-learning mode) in order to start the course in the current academic year 2016-17 itself and the Dean, Faculty of Arts endorsed the same.

The Standing Committee of the Academic Council recommended to approve the Scheme and Syllabus of the Post Graduate Diploma Course in Technical Communication (e-learning mode).

The Academic Council considered the above matter and **RESOLVED** to approve the Scheme and Syllabus of the Post Graduate Diploma Course in Technical Communication (elearning mode) as approved by the additional meeting of the Board of Studies in Library and Information Science held on 16.04.2016 as endorsed by the Dean, Faculty of Arts.

92. Eligibility to apply online PG admissions in History in affiliated Colleges 2016-2017- Consideration of - reg. (Ac.A.II)

Sri. Joseph P. Benedict, candidate graduated in Philosophy with Political Science and Sociology as subsidiaries from MG University requested for eligibility to apply online PG admissions 2016-17 in History. The candidates seeking admission PG Degree in History have to satisfy the academic eligibility as described below:

"Graduation in any subject in the Faculty of Social Sciences or Graduation in the Faculty of Arts with English Language and Literature as the main subject securing not less than 45% marks in Part III optional subjects."

In MG University Philosophy comes under the Faculty of Social Sciences whereas in Kerala University it is included in the Faculty of Arts.

The remarks of the Chairman, Board of Studies in History (PG) is as noted below:

"Though Philosophy as a subject comes under Arts, it belongs to the School of Social Science. B.A. English students are permitted to apply for M.A. History though they comes under the Arts Faculty. There is no objection to permitting BA Philosophy students to apply for M.A. History as students of sister disciplines are allowed to do so, satisfying other mandatory conditions. The Online Monitoring Committee can take a decision in this regard based on the facts stated above."

The Dean, Faculty of Arts remarked that the candidate is eligible to apply for M.A. History Programme in the University of Kerala.

The Standing Committee of the Academic Council recommended that the Degree in Philosophy with Political Science and Sociology as subsidiaries, awarded by M.G. University, be considered eligible qualification for admission to M.A (History) Programme of University of Kerala.

The Academic Council considered the above matter and **RESOLVED** that the Degree in Philosophy with Political Science and Sociology as subsidiaries, awarded by M.G. University, be considered an eligible qualification for admission to M.A (History) Programme of University of Kerala.

93. Split-Up of 4th Semester Project CA marks for M.Sc Degree Course in Physics – clarification – Consideration of - reg. (Ac.A.II)

In the Scheme of M.Sc Degree course in Physics w.e.f 2014 admission, an internal component for 25 marks was included, for which no split-up was specified. Hence the Computer Centre provided an identical interface to all colleges that is followed for practical courses with the following split-up pattern.

The Chairman, BoS, Physics (PG) recommended that since all the colleges have entered the marks in the above format, no exigency exists as far as the preparation of result of current S4 batch is concerned and *the change in pattern need be done only from next year onwards and also suggested that this matter be placed as an agenda in the next Annual Meeting of the Board of Studies to finalize the format for the split of CA marks for the project.* The Dean, Faculty of Science endorsed the above remarks of the Chairman, Board of Studies in Physics (PG).

The Standing Committee of the Academic Council recommended not to approve the proposal. Further recommended to refer the item back to the Board of Studies to formulate consolidated marks for Projects as laid down in the University Regulations and to incorporate consolidated marks in the mark lists in respect of the candidates who have completed M.Sc Degree programme in Physics in consonance with the Regulations for PG Courses.

The Academic Council considered the above matter and **RESOLVED** not to approve the proposal.

Further **RESOLVED** to refer the item back to the Board of Studies to formulate consolidated marks for Projects as laid down in the University Regulations and to incorporate consolidated marks in the mark lists in respect of the candidates who have completed M.Sc Degree programme in Physics in consonance with the Regulations for PG Courses.

94. M.Sc. Psychology - Revised guidelines for calculation of index marks and preparation of final rank list for admission to affiliated colleges – Consideration of reg. (Ac.A.II)

The students of B.Sc. Psychology, complained that eligibility criteria for admission to M.Sc. Psychology as fixed by the University is skewed (U.O Ac.AII/2/45614/M.Sc Counseling/2013 dated 25/6/2014) and in all respect shows injustice to the B.Sc Psychology students. By virtue of the existing criteria, they get a meagre advantage of 15 marks in the index for admission to PG while their due seats for M.Sc Psychology are pocketed by the students of other stream. They requested that the criteria be revised so that Graduates of Psychology get preference over the graduates of other streams for admission to M.Sc. (Psychology).

The above matter was placed before the Additional Board of Studies in Psychology (PG) and BoS meeting held on 12.08.2016 recommended to revise the guidelines for preparation of index marks and final rank list for admission to M.Sc. Psychology course in affiliated colleges as follows :

1. Eligibility criteria

The board resolved that the existing eligibility criteria which specifies three different categories of applicants as eligible for admission to M.Sc Degree course is Psychology may be continued without change.

- 2. Admission criteria
 - a. Preparation of index mark.

Index marks may be prepared as per the existing formula in the University. However a weightage of 15% of the maximum possible index marks (eg. 150 marks when the maximum possible index marks is 1000) may be added to the index marks thus prepared in the case of graduates in Psychology (who come under eligibility criteria 1) as additional weightage.

b. Preparation of final rank list and admission.

Rank list may be prepared on the basis of the final index marks obtained as specified above and admissions shall be made following the norms stipulated by the University.

The Dean, Faculty of Science endorsed the above recommendations contained in the minutes of the Additional meeting of the Board of Studies in Psychology (PG) held on 12.08.2016.

The Standing Committee of the Academic Council recommended to approve the proposal.

The Academic Council considered the above matter and **RESOLVED** to approve the revision in the guidelines for admission criteria, preparation of index marks and final rank list for admission to M.Sc. Psychology course in affiliated colleges as recommended by the BoS in Psychology (PG) and endorsed by the Dean, Faculty of Science.

95. Recognition of Ph.D.Degree in Environmental Sciences awarded to Smt. Vijayalekshmi.L.J., by the University of Kerala -Consideration of – reg. (Ac.C)

Smt.Vijayalekshmi.L.J., applied for course recognition of her Ph.D Degree in Environmental Sciences awarded by the University of Kerala, for the thesis titled "INVESTIGATIONS ON THIRST QUENCHING HERBAL PRODUCTS ON WATER QUALITY" for the purpose of getting advance increment as she is at present working as Assistant Professor in Zoology BAM College, Thuruthicad. The candidate obtained B.Sc.Degree in Zoology, M.Sc.Degree in Zoology and M.Phil Degree in Environmental Sciences from the University of Kerala.

The Chairman, Board of Studies in Zoology(P.G) remarked that the content of the Ph.D thesis of Dr.Vijayalekshmi.L.J in Environmental Sciences is not related to Zoology/Animal Sciences. It is also stated that the Ph.D in Environmental Sciences is under the Faculty of Applied Sciences and Technology which cannot be equated to a Ph.D Degree in Science Faculty. Hence the Ph.D Degree in Environmental Sciences submitted by Smt.Vijayalekshmi.L.J cannot be considered as equivalent to Ph.D Degree in Zoology of the University of Kerala. The Dean, Faculty of Science after considering the above remarks recommended to place the matter before the Faculty of Science for discussion.

The Faculty of Science at its meeting held on 02/04/2016 vide item No.VI(b) considered the matter regarding the recognition of the Ph.D Degree in Environmental Sciences awarded by the University of Kerala for the purpose of getting advance increment in the field of Zoology and recommended to recognize the said Degree for employment and higher studies. The Academic Council at its meeting held on 18.04.2016 approved the recommendation of the Faculty of Science.

A further clarification was obtained from the Dean, Faculty of Science. The Dean has recommended to grant recognition to the Ph.D Degree in Environmental Sciences awarded by the University for the thesis titled "INVESTIGATIONS ON THIRST QUENCHING HERBAL PRODUCTS ON WATER QUALITY" as an eligible Ph.D Degree in the field of Zoology for getting employment benefits and higher studies in Zoology.

The Standing Committee of the Academic Council recommended to recognise the Ph.D Degree in Environmental Sciences awarded by the University of Kerala as an eligible qualification for higher studies and employment in the field of Zoology.

The Academic Council considered the above matter and **RESOLVED** to refer the item to a combined meeting of the Board of Studies in Zoology (PG) and Environmental Sciences.

96. UGC Regulation 2016 (Credit Frame work for online Learning Courses through SWAYAM) - Approval - Consideration of - reg. (Ac.A.II)

The UGC regulation 2016 relating to Credit Frame work for online Learning Courses through SWAYAM notified by Government of India Gazette No.295 on July 2016 and as per section 7 of the same, the Regulation has to be adopted within 4 weeks.

The draft Regulations relating to credit frame work for online learning courses through SWAYAM was considered by the Standing Committee of the Academic Council, at its meeting held on 20/09/2016 and recommended to adopt the Regulations with the following incorporated under clause 2.1 of the Regulations.

"These Regulations shall also be applicable mutatis mutandis to any platform evolved by the University of Kerala for MOOC or to any platform recognized as equivalent to SWAYAM by the University of Kerala."

The Standing Committee of the Academic Council recommended to adopt the Regulations with the proposed modification, incorporated under Clause 2.1 of the Regulations.

The Academic Council considered the above matter and **RESOLVED** to adopt the Regulations with the proposed modification, incorporated under Clause 2.1 of the Regulations.
