The Special Meeting was called to order at 10.00 am by Dr. Mohanan Kunnummal, Honorable Vice-Chancellor, in the chair. The chair welcomed all members present.

Dr. Soju S, a member of the Senate, raised a point of order. He highlighted that the last seven Senate meetings were special meetings, which had denied members their rights to ask questions, move resolutions and discuss various issues. The member therefore demanded the chair to declare a date for an ordinary Senate meeting, which was also demanded by a few other members.

In reply, the chair announced that it has already been decided to convene an ordinary meeting of the Senate on February 4, 2025.

The chair then invited Dr. Rahim K, Member, Syndicate and Convenor of the Standing Committee of the Syndicate on Examinations, to move the resolution regarding the award of degrees, which was the sole agenda of the meeting.

Business brought forward by the Vice-Chancellor and the Syndicate.

01. Award of Degrees, Diplomas, Titles and Certificates. (C.E/D.D)

The Following resolution moved by Dr. Rahim K, Member, Syndicate and Convenor, Standing Committee of the Syndicate on Examinations and seconded by Dr. S Nazeeb, Member, Syndicate was unanimously adopted by the House.

“That, all candidates who have passed the various examinations under the different Faculties and also those who carried on research under the prescribed conditions and who have been adjudged worthy, to be awarded the Research Degrees under the various faculties and whom the Syndicate during the period from 18th June, 2024 to 11th November, 2024 on the report of the examiners, has certified to be qualified to receive the respective Titles, Diploma, Certificates and Degrees and those students of Autonomous Colleges who have successfully completed their course of study and are duly recommended by the Governing Council of the respective Autonomous Colleges during the aforesaid period for award of Degrees be admitted to those Titles, Diplomas, Certificates and Degrees and in token thereof they may be presented with the respective Titles, Diplomas, Certificates and Degrees.”

The Chair thanked the Members for their co-operation.

The meeting was adjourned at 10.15 a.m.
