Item No.1 Department of Chemistry - Proposal for Oxygen Plant in Kariavattom Campus-Reg

(Ad.DIII)

Dr.Jayasree E.G, Assistant Professor and Head of the Department of Chemistry, vide her mail dated 17.05.2021, has forwarded the proposal for the Installation of gaseous Medical Oxygen Generator Plant with Booster facility for Cylinder filling. It has also stated by the Head of the Department that the proposal was formulated after conducting several discussions with various experts and suppliers by the Committee constituted to study the possibility of oxygen generation in the Campus and requested that steps may be taken to consider the proposal.

<u>The proposal for the Installation of gaseous Medical Oxygen Generator Plant</u> with Booster facility for Cylinder Filling is as follows;

The second wave of COVID-19 has badly affected India with increased number of positive cases and increased mortality rate. All the data and reports indicate the more infectious and highly virulent nature of the COVID 19 virus in the second wave. One of the severe symptoms associated with the virus is the lung infection, associated Pulmonary Pneumonia and oxygen deficiency leading to the death of many patients. Many parts of India are facing lack of availability of sufficient medical oxygen for the needy patients.

Many deaths are also reported due to the critical shortage of medical oxygen supplies and of late, Kerala is also facing or going to face severe problems of oxygen availability, if the critical COVID cases spike in the coming days. In the wake of these, the Hon'ble Vice Chancellor of the University of Kerala held a meeting on 7th May, 2021 and remarked on the concerns of the increasing COVID cases in Kerala and the necessity for ensuring medical oxygen availability. He has emphasized the need for the University of Kerala to come forward and help the Government in all matters in COVID 19 Management, particularly in ensuring medical oxygen supply to the needy. Taking account of the exigency of the situation, VC has constituted a committee to evaluate the prospects of installing a medical oxygen plant in the campus.

The immediate goal should be to explore the possibility of establishing a plant in the Campus thereby ensuring the supply of medical oxygen to the nearby Government Hospitals. The Committee was entrusted to discuss with the various stakeholders and submit a proposal at the earliest for consideration by the Syndicate of the University.

The Committee discussed the matter at length with the leading suppliers of Medical Oxygen Plants and after evaluating the budgetary quotes, the Committee wishes to submit the Proposal emphasizing the following important points:-

- 1. To install an Oxygen Generator with PSA technology: Pressure Swing Adsorption (PSA) technology is the newest and the most popularly used technology for generating molecular oxygen. This is molecular sieve based technology to produce low cost oxygen from Air. PSA devices are reported to be suited for oxygen production with a purity upto 95% (medical grade oxygen). A capacity of 400-600/1 Per Minute will be more suitable for our requirement which can generate 80-100 cylinders per day. Another important feature of the plant is that it can be installed in ground floor/terrace/basement or room with one wall open to air.
- 2. A separate unit is required to give up to 99.9 percent of purity of oxygen which can be an optional for laboratory usage of molecular oxygen for research purposes thereby ensuring sustainable use of the facility. This module can be added at a later stage, if needed.
- 3. Booster/Cylinder Filling Station: Since the generated oxygen is at a low pressure, a booster would be required to fill the oxygen into cylinders for facilitating transport and supply. A booster plant for filling 80-100 cylinders/day is suitable for the plant proposed.
- 4. All the precautions, especially medical sterile filter ensuring oxygen quality for medical purposes must be ensured and must be decided through expert evaluation of the proposals from the Firms.
- 5. Sufficient manpower must be ensured through contract appointment or through redeployment of persons.

Major concern today is the lack of availability of boosters in the market and the purchase of cylinders separately as most of the firms, which supply oxygen generators, do not supply cylinders.

As per the orders of the Vice-Chancellor, proposal for the Installation of gaseous Medical Oxygen Generator Plant with Booster facility for Cylinder filling is placed before the Syndicate for Consideration.

Further Resolved to entrust the Department of Bio-chemistry & Department of Bio-technology to study the feasibility of the proposal for setting up of RT PCR lab, in consultation with Government.

ALSO RESOLVED to entrust Department of Bio-Chemistry to take immediate step to set up Virology Lab as per the Budget provision provided for the year 2021-2022 and the details of the same be reported to the Syndicate.

Item No.3 Appointment of Teachers - System of Reservation treating University as a Unit - Judgment quashing the appointments - Filing of appeal -Reporting of reg.

(Ad.H)

The Section 6 Subsection (2) of Kerala University Act, 1974, which read as follows: "In making appointments by direct recruitment to posts in any class or category in each department under the University, or to posts of non-teaching staff in the University, the University shall mutatis mutandis observe the provisions of clauses (a), (b) and (c) of rule 14 and rules 15 to 16 and 17 of the Kerala State and Subordinate Service Rules, 1958, as amended from time to time".

was replaced initially by Ordinance 49/2013 and later by Act 26/2014 with the following

:

"In making appointments to the teaching and non-teaching posts, the University shall, mutatis mutandis, observe the provisions of clauses (a), (b) and (c) of rule 14 and the provisions of rules 15, 16, 17 and 17A of the Kerala State and Subordinate Services Rules, 1958 as amended from time to time, and communal rotation shall be followed category-wise treating all the departments as one unit".

In place of the practice of following individual rotation chart for each cadre separately for each Department, each cadre of teaching posts irrespective of the subject/department was therefore required to be pooled together for the purpose of applying reservation. The University therefore prepared detailed norms for implementing the aforesaid amendment vide U.O. dated 25-10-2017. All vacancies that were brought under the new system was pooled under three categories of teaching posts viz. Assistant Professors, Associate Professors and Professors. Three separate rosters for the 3 cadres were maintained and open and reservations turns were assigned as per the 100 turn rotation chart followed by KPSC in adherence to the provisions of KS&SSR, with provision for 3% reservation to PWD (Persons with disabilities) candidates.

The first notification following the aforesaid modification was issued in November 2017 separately for the 3 cadres of teaching posts. 43 vacancies of Assistant Professors, 32 vacancies of Associate Professor and 30 vacancies of Professors were notified. 7 vacancies which were already assigned open/reservation turns (1 vacancy of Assistant Professor, 3 vacancies of Associate Professor and 3 vacancies of Professors) were also notified in 2019. A total of 58 appointments (Assistant Professors-36, Associate Professors - 10 & Professors - 12) have been made by the University (including 1 Assistant Professor - not joined duty and 1 Assistant Professors - relieved after joining).

The Writ Petitions WP(C) No.1592/2018 filed by Social Surveillance Society, WP(C) No.4592 filed by Dr. G Radhakrishna Pillai and WP(C) No.8334/2018 filed by Dr.T Vijayalakshmi, all challenged the legal validity of the system of pooling treating the University as a unit. The court did not even order a stay on further processing of applications during the time of filing the writ petitions or during the time when the university was carrying out the selection process. All the aforesaid appointments therefore were made subject to the disposal of the writ petitions.

The Judgment dated 31-03-2021 disposing the 3 writ petitions, had initially nullified the notifications of the University. The Judgment dated 31-03-2021 later uploaded in the website replaced the initial one and was found to have nullified the notifications dated 27-11-2017, the norms of the university for pooling of posts dated 25-10-2017 and the Act 26/2014 (notified in the gazette dated 20-07- 2014) which formed the basis for treating institution as a unit for applying reservation roster. It is also pointed out that the Act 26/2014 had introduced similar provision of reservation in the Act of other universities in Kerala and hence the impact of judgment would have impact on the appointments made by other universities too.

As directed by the Vice-Chancellor, the Standing Counsel has been requested to initiate necessary action for filing an appeal before the Hon'ble High Court against the judgment dated 31-03-2021 for protecting the appointments made by the University which was made strictly in accordance with the law laid down by the Government. The Hon'ble Vice-Chancellor has addressed the Chief Minister and the Principal Secretary Higher Education Dept for the support of the Government in the matter, as it is an issue common to all universities in Kerala and is based on the implementation of the law brought in to effect by the State.

The action taken by the Vice-Chancellor in having instructed the Standing

Counsel to file an appeal before the High Court against the judgment dated 31.03.2021 and in having addressed the Govt for its support by filing appeal from the side of the Govt also, are reported to the Syndicate.

Resolution of the Syndicate

RESOLVED that the action taken by the Vice-Chancellor in having accorded sanction as detailed above, be noted.

The UGC vide letter No.F.1-5/2006(SCT) dated 08.03.2019 had clarified that for the purpose of reservation of posts in direct recruitment in Teachers' Cadre, the University/College/Institution shall be regarded as one unit. Considering the fact, the Syndicate **FURTHER RESOLVED** to address the matter to UGC for the support, as it is an issue common to all Universities in Kerala and is based on the implementation of the law brought in to effect by the State.

ALSO RESOLVED to initiate urgent steps to re-constitute the Legal Monitoring Committee and the same be reported to the Syndicate.

Accordingly, the proposal for amendment to Sl.No. 117 and SL.No.118 in the Schedule under Chapter XVII, "Scales of Pay, Qualification etc. of various posts in the University" of the Kerala University First Ordinances, 1978 is laid before the Syndicate as envisaged under Section 37(1) of the Kerala University Act, 1974 for consideration and adoption.
