#### Item No. 2. Appointment of Pro-Vice-Chancellor – Approval of Syndicate – reg

The post of the Pro-Vice-Chancellor of the University is lying vacant since the expiry of the term of appointment of Dr.N.Veeramanikandan on 22 August, 2017.

A proposal was earlier placed by the Vice-Chancellor before the Syndicate held on 11.08.2017 but was then opposed by a majority of the members of the Syndicate.

The Vice-Chancellor has ordered to take appropriate action for the appointment of Pro-Vice-Chancellor strictly adhering to the provisions of UGC Regulations 2010. The relevant Clause of the UGC Regulations is as quoted below:

'As per Clause 7.1.0 of the UGC Regulations the Pro-Vice-Chancellor may be a whole time Professor of the University and shall be appointed by the Executive Council on the recommendations of the Vice-Chancellor and as per Clause 7.2.0 the Pro-Vice-Chancellor shall hold office for a period which is co-terminus with that of the Vice-Chancellor'.

The recommendation of the Vice-Chancellor will be placed before the Syndicate.

#### Item No. 3. Draft Annual Report 2017 - Approval of Syndicate - reg.

It was further resolved to refer the item back to the Editorial Committee for consideration and incorporating the corrections/ suggestions putforth by the members and to place the draft report before the Syndicate meeting.

In compliance with the Syndicate decision, the Editorial Committee held on 27.02.2018 considered the draft of the Annual report 2017 along with the corrections/ suggestions and recommended to approve the same incorporating the corrections/ suggestions.
