Sri. Ramachandran Nair, former Vice-Chancellor has submitted the UGC Pay Revision Arrear Bills amounting to Rs.12,14,337/- for the I, II and III instalments on 05/09/2018. But due to lack of funds, the bill has not been passed yet. He has now requested to disburse the arrears urgently, as he has retired long back and aged. He had retired on 18/08/2008.

Now there is an intimation from the Higher Education Department that the expense for the IV installment of UGC Pay Revision Arrears is to be met from the current years non-plan budget provision of the University.

In a similar case, as per the orders of Hon'ble Vice-Chancellor, an amount of Rs.3,20,410/has been passed to Sri.Muraleedhara Kurup (I instalment of UGC Pay Revision arrears) meeting the expense from KUF.

The matter is placed for consideration and resolution on whether,

- a) The UGC Pay Revision Arrears of Sri.Ramachandran Nair amounting to Rs.12,14,337/-(Rupees Twelve lakhs fourteen thousand three hundred and thirty seven only) may be released meeting the expense from KUF and to recoup the same from the non-plan budget provision of the University.
- b) The amount of Rs.3,20,410/- (Rupees Three lakh twenty thousand four hundred and ten only) already disbursed to Sri.Muraleedhara Kurup from KUF be recouped from the non-plan budget provision of the University.

Item No. 01.08.01: UG/PG Admission 2019 - Verification of sports Quota Applications – Framing of modalities – reg.

Item No. 01.08.02: UG/PG Admission 2019 - Verification of sports Quota Applications –Panel of teachers forwarded by DPE - reg.

As per the minutes of the meeting of the OAMC held on 24/05/2019, approved by the Vice Chancellor subject to reporting to Syndicate, the following proposal was approved for verification of documents for Sports Quota admission.

- The Director, Dept. of Physical Education may be requested to submit a panel of Physical Education Teachers from Affiliated Colleges for verification of certificates and applications submitted by the candidates for sports Quota Admissions.
- The total applications received for sports quota admissions will be equally divided and distributed among the panel of teachers.
- The panels are to be approved by the OAMC.
- The Physical Education Teachers included in the panel may be paid eligible TA/DA as per University Rules.

Accordingly the Director, Dept. Of Physical Education has forwarded a panel of teachers of 31 members for the verification of certificates. The panel is submitted for approval.

Item No. 01.08.03: Circular from Additional Director, Department of Collegiate Education – Levying of additional fee from SC/ST candidates by Self Financing colleges – reg.

It has come into the attention of the Directorate that the SC/ST candidates have taking admission in Self Financing colleges where fee concession is not availed. The students are aware about the non availability of fee concession only when they apply for reimbursement. Hence, it has been informed that the course wise fee details of self financing colleges may be included in the admission website at the time of online registration.

The committee considered the matter and recommended to direct the Management of all Self Financing Colleges to publish the details of fee levied by the college under different heads for UG/PG courses in the college website and in the prospectus of the college if any. The same shall also be given in the admission website along with the commencement of online registration for UG-PG courses from the next academic year onwards. Further recommended that, the same may also be informed to the Director, Department of Collegiate Education.

It has been informed that Government has decided to permit the universities to enhance a maximum 20% seats in various PG courses in the affiliated colleges for the academic year 2019-20. The increase should be within the statutory limit.

The Syndicate at its meeting held on 19/02/2019 has resolved to invite requests for additional marginal increase of 20% from all affiliated Govt./Aided Arts & Science Colleges/UIT's and the seat matrix may be prepared taking into account of the said seats also.

Accordingly, the decision has been implemented and seat matrix has been prepared including the additional marginal increase of 20% in all affiliated Govt./Aided Arts & Science Colleges/UIT's as per request.

In the e-mail it has been stated that, since it is difficult to accommodate more than 30 students in the class room for MA Malayalam, the total seats may be limited to 30 including marginal increase. It may be noted that a total seats of 35 including marginal increase has been granted for MA Malayalam course as per the request of the college. The allotment has been given to the above seats.

The committee considered the matter and recommended not to agree to the request as the allotments for PG courses has already been given to the above seats.

Item No. 01.08.06: Request received from faculties of B. Sc. Botany and Biotechnology and B. Sc. Biotechnology (Multimajor) of various colleges - Correction in index mark calculation for the courses M.Sc. Botany and M. Sc. Zoology - reg.

In the request it has been stated that, the candidates who have studied B. Sc. Botany and Biotechnology and B. Sc. Biotechnology (Multimajor) course, have come far behind in the ranklist for M. Sc. Botany/Zoology/Biotechnology courses. This is due the discrepancy in the calculation of index mark. Even though they studied Botany (Core 1) and Biotechnology (Vocational Core) as the main papers, only the mark of Botany is counted for index mark calculation. Hence, it has been suggested that the Core 1 Botany/Zoology marks may be considered for the index mark calculation for M.Sc. Botany/ Zoology and Core 2 Biotechnology marks may be considered for the index mark calculation for M. Sc. Biotechnology/All applied Science courses.

It may be noted that in the case of students who have studied B.Sc. Botany and Biotechnology, the index mark calculation for M.Sc. Botany is done using the Core 1 Botany marks and the index mark calculation for M.Sc. Biotechnology is done using the Core 2 Biotechnology marks.

The committee considered the request and recommended to obtain remarks from the Ac.A IV section on the matter.

The candidates were completed B.Sc Physics course from TKM College of Arts and Science, Kollam. Since they were participants in the NCC activities for the last three years, they are eligible for a grace mark. The first allotment for the PG was published on 12.06.2019 evening and their grace marks were awarded after that. So these marks were not considered for index mark calculation during the PG allotments. Now the grace marks are awarded and they have got an index mark greater than the last index mark of the College of their first preference. Now they can't change the academic details according to the new marks as the edit option is not available on the portal. The candidates have requested that they may be allowed to edit the academic details on the PG admissions portal so that their increased marks may be considered for the second allotment.

The committee considered the request and recommended that the site may be opened to the candidates for effecting necessary corrections in the profile from 17.06.2019 to 24.06.2019.

Only Government College offering the said course is University College, TVPM where there are only 5 merit seats for the course. Hence it is difficult for the B.Sc. Geography graduates to get admission. Hence it has been requested that additional seats may be sanctioned for M.Sc. Geography course at University College, TVPM.

It may be noted that the sanctioned strength for M.Sc. Geography course at University College is 10 and the college has not requested for marginal increase of seats.

The committee considered the request and recommended that a request may be forwarded to the Principal, University College, Thiruvananthapuram to apply for marginal

increase of seats for M.Sc. Geography course, considering the request submitted by the B.Sc. Geography graduates.

- **3.** The colleges to which the candidate applies for community quota will be decided based on the caste and community provided during the registration process.
- **4.** Candidates will not be allowed to make changes in their caste or community once they submit their options for Community Quota admissions.
- **5.** The registration window will last at least one week.
- **6.** Ranklist for community quota will be published two days after the close of registration. The ranklist could be viewed both by the students and by the Principals through college login portal.
- 7. The admission to Community Quota students shall be done at all colleges on a pre-decided date. If need be or to make it convenient to all concerned, the admission for different courses (B.A., B.Sc., B.Com.) may be done on different days. The communication shall be given to the concerned students through SMS and recurring press releases. The colleges shall also be informed well in advance.
- **8.** The concerned applicant or any of his/her representative should present themselves at the college venue before 1PM on the admission day with all relevant and original documents required for admission. No candidate who present themselves after 1PM shall be considered.
- **9.** All present candidates should fill up a form issued by the University and hand it over to the College Principal. The form shall contain minimum personal details, along with the time of submitting the application. The form shall also have a counterfoil to be handed back to the candidate, duly signed by the Principal clearly specifying the time of submitting application. This counterfoil may be used by the candidate as a proof for resolution of any complaints or queries of any malpractice at a later stage.
- **10.** The admission process shall be carried out strictly based on the ranklist prepared by the University.
- 11. If any of the claims made by the candidate in his/her profile is found to false, or if any ranked candidate fails to turn up within the stipulated time, the community seat may be allotted to the next candidate in the ranklist, if otherwise eligible.
- 12. In cases when admission is rejected to any candidate, the college official must log the reason in the remarks column provided under Community Quota Admission in the college login portal. Also, if the candidate is present at the venue, the same reason should be stated in the counterfoil of the application form handed back to the candidates. College will be unable to give online admission to the next candidate in the community quota ranklist unless the reason of rejection is clearly specified in the college login portal.

As per the prospectus for UG Admission of MG University clause 4.2 "The seats unavailed by the SC candidates will go to ST candidates and vice versa. The unavailed seats reserved for SC/ST shall be re-notified twice through print media and a special allotment shall be conducted exclusively for filling up vacant seats of SC/ST candidates. If such seats are remaining vacant even after renotification, these shall be filled as detailed below:- A. Government/Aided/Unaided Colleges except Aided Colleges run by the managements of backward minority Communities: - The unfilled seats shall be filled up from candidates belonging to OEC and in their absence, candidates belonging to SEBC. The seats that further remain unfilled will go to the open quota. B. Aided Colleges run by the managements of backward minority communities:-The unfilled seats shall be filled on the basis of the merit as per the rank list from among the applicants of the backward minority community, which runs the college."

In this context it may be noted that as per G.O (Ms.) No. 185/72/Edn. Dated 30.08.1972 from Education (D) Department, Direct Payment System and Important General Orders clause 3. Selection of students:- The selection of students for admission in the College will be on the following basis:- (1) Twenty percent of the seats shall be reserved for Scheduled Castes and Scheduled Tribes to be filled up on merit basis from among the students of Scheduled Castes/Scheduled Tribes. The seats that cannot be filled up from the quota reserved for Scheduled Castes and Scheduled Tribes, will be filled up on the basis of merit from among Backward Minority Communities and by O.B.C's in the case of colleges run by other communities.

The mismatch in the G.O related to Direct Payment System and the letter from the Principal Secretary to Govt. is brought to the notice of the committee.

Item No.01.17 Renaming of Centre for Rural Studies as Centre for Science, Rural Development and Ecology (CSRDE) - Consideration of – reg.

(Ac.D)

Sanction has been accorded by the Vice-Chancellor for the establishment of 'Centre for Rural Studies' in the University Study and Research Centre at the Alappuzha district vide U.O dated 17/09/2018 for adopting a trans-disciplinary as well as inter disciplinary approach to rural development.

Inorder to empower rural population with the input of science and technology and to provide science based solutions and a more suitable knowledge platform for sustainable rural development and economic, environmental security for rural population, the name of the Centre be changed to Centre for Science, Rural Development and Ecology(CSRDE). The Centre can be elevated to the level of an off campus department of the University to promote inter disciplinary research, education and extension and would serve as a model department to cater global demands from rural sector.

The Centre would run a master programme- PG in Rural Studies, research & consultancy centre and policy support base for rural development and empowerment. The course would be interdisciplinary in nature and all graduates from any discipline from recognised Universities would be eligible to apply.

A team of experts involving academicians, environmentalists, policy makers, rural stake holders and entrepreneurs would be constituted to create and operate an experimental learning laboratory, which will be identified in the rural setting that needs to be learned for transformational experience.

The following research departments of the University would support the Centre.

- 1. Department of Environmental Sciences,
- 2. Department of Aquatic Biology & Fisheries
- 3. Department of Economics
- 4. Department of Commerce
- 5. Department of Biotechnology
- 6. Department of Futures Studies

The matter is placed before the Syndicate for consideration.

Item No.01.18 Granting of retiral benefits to Smt. Annie Mascrene -Consideration of-reg. (Ad AIII)

Ref: 1) Judgement of the Hon'ble High Court dated **20.06.2017** in WP(C) **No. 27174/14-V** filed by **Smt. Annie Mascrene.**

2) G.O.(Rt) No.2274/18/ HEDN dated 19/12/2018 from the Higher Education (B) Department.

3) G.O.(Rt)No.935/2019/HEDN dated 11.06.2019 from the Higher Education (B) Department.

Smt. Annie Mascrene joined University service as Assistant Grade II on 28.05.1977 AN. Prior to this she had put in service as LD Clerk in the office of the Chief Welfare Fund Inspector w.e.f. 12.08.1974- 31.10.1975 and as LD Auditor from 31.10.1975-28.05.1977 in the Office of the Local Fund Audit. These prior services rendered by her have been reckoned for University pensionary benefits vide U.O No. Ad. A1.1.255/94 dated 05.08.1995. While working as selection grade assistant she placed a request to permit her to go on deputation to Navodaya Vidyalaya Samiti as Socially Useful Productive Work teacher which was not agreed to, but in turn directed her to avail of LWA for the same. Consequently she continued in the Navodaya Vidyalaya Samiti on LWA w.e.f. 20.09.1989 vide U.O dated 20.09.1989 and again requested the University to treat the period of LWA as period of deputation in the Navodaya Vidyalaya Samiti. Meanwhile the Principal, JNV, Karnataka vide letter dated 03.11.1993 expressed willingness to remit the leave salary and pension contribution admissible as per rules. Accordingly vide U.O No. Ad. A1.3/2712/93 dated 24.01.1994 sanction was accorded by University of Kerala to Smt. Annie Mascrene being permitted to go on deputation in the Navodaya Vidyalaya Samiti for a period of 5 years w.e.f. 20.09.1989 subject to the usual terms and conditions. Vide U.O dated 29.03.1994 she was promoted as Section Officer w.e.f. 13.05.1992 and allowed to continue in the Navodaya Vidyalaya Samiti on deputation.

The Navodaya Vidyalaya Samiti as per letter dated 03.10.1994 requested University of Kerala to accept the technical resignation submitted by Smt. Annie Mascrene w.e.f. 31.05.1993 remitting the leave salary and pension contribution upto 31.05.1993 so as to enable her to seek permanent absorption to Navodaya Vidyalaya Samiti which was agreed to by University of Kerala vide U.O. dated 28.06.1995. The details of remittances made by the Navodaya Vidyalaya Samiti is appended.

She retired from the service of Navodaya Vidyalaya Samiti on 31.03.2012. It may be noted that the Navodaya Vidyalaya Samiti is an autonomous organization under the ministry of HRD, Government of India which is not a pensionable service. Hence consequent to her retirement from Navodaya Vidyalaya Samiti she applied for pro-rata pension benefits from University of Kerala for the period from 12.08.1974 to 01.06.1993.

The Navodaya Vidyalaya Samiti on being requested the Joint Director, Local Fund Audit has remarked- "The technical resignation of **Smt. Annie Mascrene** w.e.f 31.05.1993 was accepted by the University. As per KSR Part III, Rule 29(a), the pre-resignation period cannot be counted for pensionary benefits as resignation resulted in the forfeiture of the entire service rendered till date of resignation. Hence Smt. Annie Mascrene is not eligible for pensionary benefits from the University".

Upon this she filed a writ petition before the Hon'ble High Court. The hon'ble High Court in WP((C) No. 27174/14- V filed by **Smt. Annie Mascrene** in its judgement dated 20.06.2017 disposed of the petition directing the government to pass fresh orders after affording an opportunity of hearing to the petitioner who shall submit a supplementary representation to the Government along with a copy of the judgement. The government shall pass orders on such representation within a period of 2 months from the date of receipt of the same. Accordingly a hearing was convened on 31.08.2017 comprising the Under Secretary, Higher education (B) Department, the petitioner and the respondents.

Eventually the Government issued the G.O. dated 19.12.2018 in the strength of the G.O(P) No: 893/1978/ Fin dated 30.12.1998 which envisages that the Government employee should exercise an option within six months of absorption for either of the alternative indicated below:

- (a) Receiving the monthly Pension and DCRG already worked out, under the usual Government arrangements.
- (b) Receiving the gratuity and a lumpsum amount in lieu of pension worked out with reference to commutation tables obtaining on the date from which the pro-rata pension, gratuity etc will be disbursable.

Where no option is exercised within the prescribed period, the officer will automatically be governed by alternative (b) above. Here in this case as Smt. Annie Mascrene has not furnished any option, option (b) is applicable for her and government thereby declared that Smt. Annie Mascrene is eligible for receiving the gratuity and a lumpsum amount in lieu of pension worked out with reference to commutation tables obtaining on the date from which the pro-rata

pension, gratuity etc will be disbursable and thus complying with the orders of the Hon'ble High Court.

The Syndicate at its meeting held on **25.05.2019** considered the matter and resolved that the recommendation of the Standing Committee of the Syndicate on Finance held on 16.05.2019 to comply with the direction of the Government as per existing rules and regulation of the pension, be approved. The resolution of the Syndicate has been approved by the Vice-Chancellor also.

Meanwhile, another revised **G.O(Rt)No.935/2019/Edu dated 11.06.2019** has been forwarded from the Higher Education Dept. on a representation submitted by **Smt. Annie Mascrene**.

Taking into consideration, her application in not exercising an option for availing terminal benefits within six months of absorption, the Govt. have decided to condone the delay and to give an opportunity to her to exercise option (a) based on G.O(P) No.893/1978/Fin dated **30.12.1978** as a special case.

It may be noted that **Vol.II** of her Service Book is still not traceable, the fact of which has already been intimated to the Government.

In this regard, **Finance III** section has opined that the matter may be placed before the Syndicate for approval on further course of action in the light of the G.O. dated **11.06.2019**.

She has also informed that her son is mentally retarded and he needs her care and help at each and every moment. Her husband is also under the treatment for mental problem and now his depression becomes in a state of dual personality. Hence, she has requested to retain her in the present KUCTE where she is working now. (copies of medical certificate attached).
- 2. Smt. Sinimol V.M, Asst. Professor of Perspectives in Education, KUCTE, Kumarapuram has informed that she is a diabetic patient from 2005 onwards, her husband is working in Kottayam, she has the duty to look after Alzhimers affected mother-in-law, she has two daughters who are studying in Plus 2 and 10th classes and they need her care and attention at this time. The transfer would affect her family negatively. Hence, she has requested to stop this transfer and help her to do her duty in KUCTE, Kumarapuram. (copies of medical certificate attached).
- 3. Smt. Simi.T, Asst. Professor of Mathematics, KUCTE, Kollam has informed that she has got transfer to KUCTE, Adoor, but she has not applied for transfer. She also informed that she is suffering from kidney stone and has the duty to look after her old mother. Hence, she has requested to retain her at the present KUCTE itself.
- 4. Smt. Sheenu G.S, Asst. Professor of Natural Science, KUCTE, Kollam has requested to exempt her from the transfer process as she is under the treatment for uterus related problems and it is very difficult to travel long distances.
