At least 115,000 meetings and two committees later, India's draft National Education Policy (NEP) was finally shared by the ministry of human resource development for public comment, and may soon become a policy. Notwithstanding the delay, the draft policy prepared by a team of nine experts led by space scientist Krishnaswamy Kasturirangan is perhaps the best piece of education reforms initiative in recent years.

It is quite natural that there would be both beneficial and adverse contents in every reform and the New Education Policy is also not and exemption. Through various discourses on the pros and cons of the educational reform, the seminar intends to arrive at a logical conclusion so that suggestions can be put forward to the authorities for improvising the policy announced by the Government of India.
