ORDER

As per the UGC guidelines, the maximum duration for completing a programme of study is restricted to Y+2 years for annual programmes and S+4 semesters for semester programmes, unless otherwise specified by the apex bodies, where Y and S stands for the normal or minimum duration prescribed for completion of the programme. Subsequently, UO read as paper (1) above was issued superceding the provisions contained in the Regulations of various courses and thereby stands applicable to all UG and PG courses with effect from 2016-17 admissions onwards.

An additional chance was granted to the students of First Degree Programmes of 2016 admissions for registering to the 5th Semester Supplementary Examinations, in the wake of Covid-19 Pandemic, subject to reporting to the Academic Council and UO read as (2) above was issued accordingly.

The Syndicate, vide paper read as (3) above, considered the requests from the candidates of First Degree Programmes under CBCS System of 2016 admissions to grant an additional chance to appear for the Supplementary examinations of I, II, III, IV and VI Semesters, in the wake of Covid-19 pandemic and resolved to conduct Supplementary examinations for the candidates of IV and VI Semesters of First Degree Programmes and Career-related First Degree Programmes under CBCS System of 2016 admissions. Further resolved to grant permission to conduct Mercy Chance Examinations for the candidates of I, II and III Semesters of First Degree Programmes and Career-related First Degree Programmes under CBCS System of 2016 admissions.



Sanction has, therefore, been accorded by the Vice-Chancellor, for conducting Supplementary examinations for the candidates of IV and VI Semesters and for granting

permission to conduct Mercy Chance Examination for the candidates of I, II and III Semesters of First Degree Programmes and Career-related First Degree Programmes under CBCS System, of 2016 admissions.
