## <u>ORDER</u>

The part of duty and remuneration for the valuation of answer scripts for examiners drawing salaries under the UGC Scheme were fixed as per the reference cited as (1).

The Higher Education Department had issued orders that remuneration to guest lecturers of Government/aided colleges for valuation of answerscripts in excess of the mandatory papers shall be met from the internal funds of the respective Universities which has been implemented in the University vide U.O read as (2) above. Subsequently the Higher Education Department had sought remarks of the University on the report furnished by the Director of Collegiate Education relating to the mode of disbursement of remuneration to guest lecturers and the granting of OD for participating in the centralised valuation camps of the University, which was placed before the Syndicate for consideration.

The Syndicate, as per the reference cited as (4), considered the opinion of the Director of Collegiate Education, and resolved that the part of duty for the valuation of answer scripts, currently applicable to teachers drawing salaries under the UGC Scheme as per reference (1), shall also be made applicable to Guest Lecturers working in Government and Aided Colleges.

Sanction has therefore been accorded by the Hon'ble Vice-Chancellor to fix the part of duty for Guest Lecturers from Government and Aided colleges for the valuation of answer scripts in the same manner as applicable to teachers drawing salaries under the UGC Scheme.

This order is issued in accordance with Finance Endorsement No. FOS.5322/Finance I/2024-25 dated 24.03.2025.
