ORDER

The rate of remuneration for the conduct of practical examinations for B.Tech courses is as per UO read as (1) above.Due to low remuneration, there is an inavailabilty of examiners for the conduct of practical examinations of B.Tech courses.

As per paper read as (2) above regarding the processing of pending bills of B.Tech Examinations, Assistant Registrar (B.Tech) was entrusted to put up a proposal for fixing a minimum amount as remuneration to both internal and external examiners for conducting lab exams irrespective of the number of students.

The Assistant Registrar (B.Tech) submitted a proposal stating a minimum amount of ₹1000/- (Rupees one thousand only) and over and above ₹1000/-(Rupees one thousand only)(if the number of candidates exceeds accordingly), as remuneration for the conduct of practical examinations of B.Tech (both internal and external) considering the suggestion of EC section.

The Combined meeting of the Standing Committees of the Syndicate on Examinations and Finance, vide paper read as (3) above considered the matter and recommended that the remuneration for the external examiners for the conduct of practical examinations of the B.Tech courses be fixed as follows:

No. of candidates	Remuneration including TA/DA
1 to 8	₹1000/-
Above 8	₹1000+₹50 for each additional candidates

The Syndicate, at its meeting held on 08/12/2022, vide paper read as (4) above, resolved to approve the above recommendation of the Combined meeting of the Standing Committees of the Syndicate on Examinations and Finance.

Sanction has been accorded by the Vice-Chancellor for implementing the above resolution of the Syndicate.
