ORDER

The norms for the improvement of sessional marks of B.Tech Degree course for the failed candidates after completion of the course (2008 scheme) have been framed vide paper read (1) and (2) above. The failed candidates who completed five years after joining the B.Tech Degree course have been permitted only one chance to improve the sessional/ CA marks of the equivalent subject in the existing 2013 scheme along with the regular batch at the respective colleges. The candidates shall attend the University examinations of the paper in which he/she has improved the sessionals.

Considering the requests of the candidates vide paper read (3) above, remarks of the Chairmen, Boards of Studies in Engineering (Part I,II & III) was obtained regarding award of moderation of marks. It has been recommended vide paper read (4) above, that the candidates are eligible for subject moderation if any, awarded by the pass board and general moderation if awarded shall be given proportionately based on the number of subjects appeared, provided the candidates earn complete semester pass in the respective scheme. This shall be applicable to both schemes.

Sanction has been accorded by the Pro Vice Chancellor, for granting moderation of marks for sessional improvement candidates of the B.Tech Degree course as recommended by the Chairman, BOS in Engineering. (pass 1,11 & III).
