- 1. The main envelop should be super scribed: "Quotation for the supply of Air conditioner".
- 2. Only one model can be quoted in a tender. If the tenderer wants to quote for more than one model separate tenders should be submitted. If more than one model is quoted in a single tender it will be summarily rejected.
