## Technical Specifications

### I. Autoclave with drying facility and programme

- (a) Portable automatic laboratory autoclave with digital status indicator and drying suitable for instruments and liquids.
- (b) Horizontal type is preferred with standard large chamber that can accommodate normal sterilizing cans.
- (c) Working temperature: 100 – 130°C
- (d) Sterilization timer: 10 - 60 min or better
- (e) Operating pressure 10-15 psi or better
- (f) Drying facility after autoclaving
- (g) Required protective safety mechanisms related to high temperature and pressure.

Minimum 3 years warranty

### **GENERAL INSTRUCTIONS**

1. The Bidder should be a manufacturer or their dealer specifically authorised by the manufacturer to quote on their behalf for this tender as per Manufacturer Authorisation Form and Indian agents of foreign principals , if any. Who must have designed, manufactured, tested and supplied the equipment(s) similar to the type specified in the “Technical Specification”. Such equipments must be of the most recent series/models incorporating the latest improvements in design. The models should be in successful operation for at least one year as on date of Bid Opening.
2. Incomplete & conditional tenders and tenders received after the due date will be summarily rejected without assigning any reasons thereof.
3. The price should be inclusive of all taxes, duties, transportation, installation etc. Nothing extra will be paid in addition to the quoted rate.
4. **Payment Terms:** **90%** payment shall be made through irrevocable L/C on presentation of complete and clear shipping documents and balance **10%** of the amount shall be released after the receipt, installation, commissioning and acceptance of the equipment.

5. **Validity of tender:** Tender submitted shall remain valid at least for 90 days from the date of opening the tender. Validity beyond three months from the date of opening of the tender shall be by mutual consent.
6. **Delivery and installation:** Proposed delivery schedule should be mentioned clearly. Delivery and installation should be made at the Department of Biochemistry, University of Kerala, Kariavattom campus, Trivandrum- 695581, without any extra cost.
